1. Business

The company was incorporated on 5 February 1988. The company did not operate during the year ended 31 December 2000 and made neither profits nor losses.

3. Holding Company

As at 31 December 2000 the company was wholly owned by Channel Four Television Corporation, a statutory corporation formed in the UK under the terms of the Broadcasting Act 1990.

With effect from 1 January 2001 the company's entire issued share capital was transferred to 4 Ventures Limited, a wholly owned subsidiary of Channel Four Television Corporation.
