**BETWEEN:-**

- (1) **EAGLEMOSS LIMITED** (a company registered in England and Wales with company number 02226335) whose registered office is at Premier Place, 2 & A Half Devonshire Square, London, England, EC2M 4UJ (the "Chargor"); and
- (2) **SANTANDER UK PLC** (registered in England with number 2294747) whose registered office is at 2 Triton Square, Regent's Place, London NW1 3AN as agent and security trustee for each of itself and each Secured Party (the "Security Trustee" which expression shall include its successors in title, assigns and transferees).

**IT IS AGREED as follows:-**

**1. INTERPRETATION**

**1.1 Definitions**

<b>"Affiliate"</b>	means, in relation to a person, a Subsidiary of that person, a Holding Company of that person or any other Subsidiary of that Holding Company, in each case, from time to time
<b>"Charged Property"</b>	means all the property, assets and undertaking of the Chargor which from time to time are, or are expressed to be, the subject of the Security created in favour of the Security Trustee by or pursuant to this Deed
<b>"Default Rate"</b>	means the rate of interest specified in, and calculated in accordance with, clause 9.3 of the Facilities Agreement
<b>"Facilities Agreement"</b>	means the term and revolving facilities agreement dated 5 April 2019, as amended and restated by amendment and restatement agreements dated 14 November 2019 and 23 June 2020, as further amended by an amendment letter dated 17 August 2021 and as further amended by an amendment letter dated on or about the date of this Deed made between Eagle Moss Capital Limited as Borrower, the Chargor as Original Guarantor and the Security Trustee (as Lender)
<b>"Holding Company"</b>	means, in relation to a person, any person in respect of which it is a Subsidiary

<b>"Intellectual Property"</b>	means the intellectual property rights set out in Schedule 1 together with all patents, rights to inventions, copyright and related rights, trade marks, trade names and domain names, rights in get-up, rights in goodwill or to sue for passing off, unfair competition rights, rights in designs, rights in computer software, database rights, rights in confidential information (including know-how and trade secrets) and any other intellectual property rights, in each case whether registered or unregistered and including all applications (and rights to apply) for, and renewals or extensions of, such rights and all similar or equivalent rights or forms of protection which subsist or will subsist, now or in the future, in any part of the world
<b>"LPA"</b>	means the Law of Property Act 1925
<b>"Party"</b>	means a party to this Deed
<b>"Receiver"</b>	means any receiver, receiver and manager or administrative receiver of the whole or any part of the Charged Property
<b>"Related Rights"</b>	<p>means in relation to any Charged Property:-</p> <ul style="list-style-type: none"><li>(a) the proceeds of sale of any part of that Charged Property;</li><li>(b) all rights under any licence, agreement for sale or agreement for lease in respect of that Charged Property;</li><li>(c) all rights, benefits, claims, contracts, warranties, remedies, security, indemnities or covenants for title in respect of that Charged Property; and</li><li>(d) any moneys and proceeds paid or payable in respect of that Charged Property</li></ul>
<b>"Secured Liabilities"</b>	means all monies and liabilities now or after the date of this Deed due, owing or incurred by the Obligors to any Secured Party whatsoever, in any manner and in any currency or currencies and whether present or future, actual or contingent, whether incurred solely or jointly with any other person and whether as principal or surety, together with all interest accruing on such monies and liabilities and all costs, charges and expenses incurred by any Secured Party, except for any obligation which, if it were included here, would constitute unlawful financial assistance, or its equivalent in any other jurisdiction
<b>"Secured Party"</b>	means the Security Trustee and each of its Affiliates
<b>"Security"</b>	means any mortgage, charge, pledge, lien, or other security interest securing any obligation of any person or any other agreement or arrangement having similar effect

**"Security Period"** means the period from the date of this Deed until the date on which the Security Trustee has determined that all of the Secured Liabilities have been irrevocably and unconditionally paid and discharged in full and all facilities which might give rise to Secured Liabilities have terminated

**"Subsidiary"** means a subsidiary undertaking within the meaning of section 1162 of the Companies Act 2006

## 1.2 Incorporation of terms

Unless the context otherwise requires or unless defined in this Deed, all words and expressions defined or whose interpretation is provided for in the Facilities Agreement have the same meanings in this Deed.

## 1.3 Interpretation

The principles of interpretation set out in clause 1.2 of the Facilities Agreement shall apply to this Deed insofar as they are relevant to it and in this Deed, unless the context otherwise requires, a reference to a "Finance Document" or any other agreement or instrument is a reference to that Finance Document or other agreement or instrument as amended, novated, supplemented, restated or replaced (however fundamentally) and includes any increase in, extension of, or change to, any facility made available under that Finance Document or other agreement or instrument.

## 1.4 Acknowledgement

The Chargor acknowledges that the Security Trustee enters into this Deed for itself and as trustee for the Secured Parties who shall be entitled to the full benefit of this Deed.

## 1.5 Effect as a deed

This Deed shall take effect as a deed even if it is signed under hand on behalf of the Security Trustee.

## 1.6 Third party rights

A person who is not a Party has no right under the Contracts (Rights of Third Parties) Act 1999 to enforce or to enjoy the benefit of any term of this Deed.

# 2. COVENANT TO PAY

## 2.1 Secured liabilities

The Chargor covenants that it will on demand pay and discharge any or all of the Secured Liabilities when due.

## 2.2 Interest

The Chargor covenants to pay interest on any sum demanded in accordance with Clause 2.1 (*Secured Liabilities*) until payment (both before and after judgment) at the Default Rate.

# 3. CHARGES

## 3.1 Fixed Charge

As a continuing security for the payment and discharge of the Secured Liabilities the Chargor with full title guarantee charges to the Security Trustee by way of first fixed charge all its rights, title and interest from time to time in and to the Intellectual Property and all Related Rights.

## 3.2 Floating Charge

3.2.1 As a continuing security for the payment and discharge of the Secured Liabilities the Chargor with full title guarantee charges to the Security Trustee by way of first floating charge all of its rights, title and interest from time to time in the whole or any part of the Intellectual Property and any Related Rights which is not for any reason effectively charged (whether in law or in equity) by way of fixed charge by this Deed.



- 3.2.2 Paragraph 14 of Schedule B1 to the Insolvency Act 1986 will apply to the floating charge created by this Deed.

#### 4. CRYSTALLISATION OF FLOATING CHARGE

##### 4.1 Crystallisation: By Notice

Subject to Clause 4.3 (*Crystallisation: Moratorium*), the Security Trustee may at any time by notice in writing to the Chargor convert the floating charge created by Clause 3.2 (*Floating Charge*) with immediate effect into a fixed charge as regards any property or assets specified in the notice if:-

- 4.1.1 a Default has occurred; or
- 4.1.2 the Security Trustee considers that any of the Charged Property may be in jeopardy or in danger of being seized or sold pursuant to any form of legal process; or
- 4.1.3 the Security Trustee considers that it is necessary in order to protect the priority of the Security created by or pursuant to this Deed.

##### 4.2 Crystallisation: Automatic

Subject to Clause 4.3 (*Crystallisation: Moratorium*), the floating charge created by Clause 3.2 (*Floating Charge*) will automatically be converted (without notice) with immediate effect into a fixed charge as regards all of the undertaking and assets subject to the floating charge if:-

- 4.2.1 the Chargor creates or attempts to create any Security (other than as permitted pursuant to the terms of the Finance Documents) over any of the Charged Property; or
- 4.2.2 any person levies or attempts to levy any distress, execution or other process against any of the Charged Property; or
- 4.2.3 any step is taken (including the presentation of a petition, the passing of a resolution or the making of an application) to appoint a liquidator, provisional liquidator, administrator or Receiver in respect of the Chargor, over all or any part of its assets, or if such person is appointed.

##### 4.3 Crystallisation: Moratorium

- 4.3.1 Notice may not be given to cause the floating charge over the assets of a Chargor created by Clause 3.2 (*Floating Charge*) to crystallise into a fixed charge whilst that Chargor is subject to a moratorium under Part A1 to the Insolvency Act 1986.
- 4.3.2 The floating charge created by Clause 3.2 (*Floating Charge*) may not be crystallised into a fixed charge solely by reason of:-
  - (a) the obtaining of a moratorium; or
  - (b) anything done with a view to obtaining a moratorium
 under Part A1 to the Insolvency Act 1986.

#### 5. REPRESENTATIONS AND WARRANTIES

The Chargor makes the representations and warranties set out in this Clause 5 to the Security Trustee.

##### 5.1 Intellectual Property

- 5.1.1 It is the legal, beneficial and registered proprietor of all the Intellectual Property.
- 5.1.2 It is not aware of any reason why any Intellectual Property may for any reason be incapable of being the subject of the Security created by this Deed.
- 5.1.3 All the Intellectual Property is valid and subsisting and, so far as the Chargor is aware, does not infringe the rights of any third party.

5.1.4 All renewal fees due in respect of the Intellectual Property have been paid.

## 5.2 Applications

5.2.1 It is the applicant for any application for registration to be made in relation to any Intellectual Property; and

5.2.2 to the best of its knowledge, there is no reason why any such application will not proceed to registration.

## 5.3 Validity and claims

5.3.1 It is not aware of any conduct, action or lack of action which will or may have the effect of prejudicing the validity of any Intellectual Property or adversely affecting its value.

5.3.2 Other than as disclosed in writing to the Security Trustee on or before the date of this Deed:

- (a) it is not restricted in any material way in its use or exercise of any Intellectual Property; and
- (b) to the best of its knowledge, information and belief (having made all reasonable enquiries), there are no licences, agreements or Security (other than in favour of the Security Trustee) which relate to or affect any Intellectual Property or the Security created by this Deed.

5.3.3 It is not aware of any claim from any third party relating to ownership of any Intellectual Property or of any claim that any Property infringes any rights of any third party.

## 5.4 Repetition

The representations and warranties set out in this Clause 5 shall survive the execution of this Deed and are deemed to be repeated by reference to the facts and circumstances then existing on each date on which the Repeating Representations are deemed to be repeated.

## 6. COVENANTS

### 6.1 Deposit of documents

6.1.1 On the date of this Deed and at all times during the Security Period as soon as it receives them (and in any event as soon as the Security Trustee so requests), the Chargor shall deposit with the Security Trustee in respect of or in connection with the Charged Property.

- (a) all deeds, certificates and other documents of or evidencing title; and
- (b) any other documents which the Security Trustee may from time to time require for perfecting its title, or the title of any purchaser.

all of which will be held by the Security Trustee at the expense and risk of the Chargor.

### 6.2 Preservation of the Charged Property

6.2.1 The Chargor shall:

- (a) protect, enforce, preserve, maintain and renew as and when necessary all Intellectual Property;
- (b) observe and perform all covenants, undertakings, laws and regulations from time to time affecting any Charged Property or the use or enjoyment of it except when non-observance or non-performance would have a Material Adverse Effect;
- (c) pay all Tax, duties, fees, charges, assessments, impositions and outgoings which are properly payable at any time during the Security Period in respect of any Charged Property (and if it fails to pay that amount when due, the Security Trustee may pay it);
- (d) at its own cost, defend any proceedings (including proceedings to seize, attach, charge, take possession of or sell) brought by a third party relating to any Charged Property.

- 6.2.2 The Chargor shall at all times during the Security Period promptly notify the Security Trustee if it receives notification, or otherwise becomes aware of:
- (a) any actual, alleged, threatened or suspected infringement of any Intellectual Property;
  - (b) any actual, alleged, threatened or suspected infringement of any third party's rights arising from the use of any Intellectual Property;
  - (c) any actual, threatened or suspected cancellation or other legal action in respect of any Intellectual Property.
- 6.2.3 The Chargor shall take all such steps, including the commencement of legal proceedings, as may be necessary to:
- (a) prosecute to registration any application for registration in respect of any intellectual property;
  - (b) safeguard and maintain the validity, reputation, integrity, registration or subsistence of the Intellectual Property.
- 6.2.4 The Chargor shall consult with and comply with the reasonable requests of the Security Trustee relating to:
- (a) any legal proceedings necessary to discharge the Chargor's obligations under Clause 6.2.3; or
  - (b) the defence of any legal proceedings brought by any third party relating to or affecting the Intellectual Property.

## 7. RESTRICTIONS AND FURTHER ASSURANCE

### 7.1 Security

The Chargor shall not create or permit to subsist any Security over any Charged Property, nor do anything else prohibited by clause 21.12 (*Negative pledge*) of the Facilities Agreement.

### 7.2 Disposal

The Chargor shall not enter into or agree to enter into a single transaction or a series of transactions (whether related or not and whether voluntary or involuntary) to sell, lease, license, sub-license, transfer or otherwise dispose of any Charged Property except as permitted by clause 21.13 (*Disposals*) of the Facilities Agreement.

### 7.3 Restrictions

The Chargor shall not:

- (a) without prior written consent of the Security Trustee, enter into any onerous obligation or restriction affecting any Intellectual Property;
- (b) without the prior written consent of the Security Trustee settle or compromise any proceedings referred to in Clause 6.2.4;
- (c) without the prior written consent of the Security Trustee, take any Security in connection with its liability under this Deed from any guarantor of, or provider of Security for, any of the Secured Liabilities.
- (d) permit any Intellectual Property to lapse for any reason or allow any thing to be done or left undone the effect of which will, or may be, to imperil or prejudice any Intellectual Property, its registration, subsistence, validity, reputation or integrity;
- (e) permit any Intellectual Property to fall into disuse or to be used in such a way that it is put at risk by becoming generic or by being identified as disreputable in any way;

- (f) without the prior written consent the Security Trustee, assign, licence, sub-licence, sever, dispose of or otherwise part with any Intellectual Property;
- (g) change the specification of any Intellectual Property or permit any disclaimer, condition, restriction or memorandum to be entered on any register on which any Intellectual Property is registered, the effect of which will or may detrimentally affect the value of any Intellectual Property;
- (h) fail to continue to prosecute any application for registration of any Intellectual Property to registration or fail to take any steps necessary to ensure so far as possible that any such application is accepted for registration by the relevant registry; or
- (i) do or cause or permit to be done anything which may in any way depreciate, jeopardise or otherwise prejudice the value to the Security Trustee of any Intellectual Property and/or the Security over any Intellectual Property created by Clause 3.

#### 7.4 Further assurance

The Chargor shall promptly do whatever the Security Trustee requires to:-

- 7.4.1 perfect or protect the Security created or expressed to be created by this Deed, or its priority; or
- 7.4.2 facilitate the realisation of the Charged Property or the exercise of any rights vested in the Security Trustee or any Receiver,

including executing any transfer, conveyance, charge, assignment or assurance of the Charged Property (whether to the Security Trustee or its nominees or otherwise), making any registration and giving any notice, order or direction.

#### 7.5 Legal mortgage

At any time after:-

- 7.5.1 the occurrence of an Event of Default which is continuing;
- 7.5.2 the occurrence of any event described in clause 22.11 (*Change of ownership*) of the Facilities Agreement;
- 7.5.3 any request being made by the Chargor to the Security Trustee for the appointment of a Receiver or an administrator, or for the Security Trustee to exercise any other power or right available to it; or
- 7.5.4 the occurrence of any event causing, or purporting to cause, the floating charge created by this Deed to become fixed in relation to any Charged Property,

then the Chargor shall promptly, if required by the Security Trustee, do whatever the Security Trustee requires to create and perfect a legal mortgage (in such form as the Security Trustee may require) of the Intellectual Property in favour of the Security Trustee.

### 8. DEMAND AND ENFORCEMENT

#### 8.1 Enforcement

The Security created by this Deed shall become enforceable upon:-

- 8.1.1 the occurrence of an Event of Default;
- 8.1.2 any request being made by the Chargor to the Security Trustee for the appointment of a Receiver or an administrator, or for the Security Trustee to exercise any other power or right available to it; or
- 8.1.3 the occurrence of any event causing, or purporting to cause, the floating charge created by this Deed to become fixed in relation to any Charged Property.

## 8.2 Powers on enforcement

At any time after the Security created by this Deed has become enforceable, the Security Trustee may (without prejudice to any other rights and remedies and without notice to the Chargor) do all or any of the following:-

- 8.2.1 exercise the power of sale under section 101 of the LPA together with all other powers and rights conferred on mortgagees by the LPA, as varied and extended by this Deed, without the restrictions contained in sections 103 or 109(1) of the LPA; and
- 8.2.2 subject to Clause 9.1 (*Method of appointment or removal*), appoint one or more persons to be a Receiver or Receivers of all or any of the Charged Property; and
- 8.2.3 appoint an Administrator of the Chargor.

## 8.3 Disposal of the Charged Property

In exercising the powers referred to in Clause 8.2 (*Powers on enforcement*), the Security Trustee or any Receiver may sell or dispose of all or any of the Charged Property at the times, in the manner and order, on the terms and conditions and for the consideration determined by it.

## 8.4 Same rights as Receiver

Any rights conferred by any Finance Document upon a Receiver may be exercised by the or to the extent permitted by law, an administrator, after the Security created by this Deed has become enforceable, whether or not the Security Trustee shall have taken possession or appointed a Receiver of the Charged Property.

## 8.5 Delegation

The Security Trustee may delegate in any manner to any person any rights exercisable by the Security Trustee under any Finance Document. Any such delegation may be made upon such terms and conditions (including power to sub-delegate) as the Security Trustee thinks fit.

## 9. RECEIVERS

### 9.1 Method of appointment or removal

Every appointment or removal of a Receiver, any delegate or any other person by the Security Trustee under this Deed shall be in writing under the hand of any officer or manager of the Security Trustee (subject to any requirement for a court order in the case of the removal of an administrative receiver).

### 9.2 Removal

The Security Trustee may (subject to the application of section 45 of the Insolvency Act 1986) remove any person from office in relation to all or any part of the Charged Property of which they are the Receiver and at any time (before or after any person shall have vacated office or ceased to act as Receiver in respect of any of such Charged Property) appoint a further or other Receiver or Receivers over all or any part of such Charged Property.

### 9.3 Powers

Every Receiver shall have and be entitled to exercise all the powers:-

- 9.3.1 of the Security Trustee under this Deed;
- 9.3.2 conferred by the LPA on mortgagees in possession and on receivers appointed under the LPA;
- 9.3.3 of an administrative receiver set out in Schedule 1 to the Insolvency Act 1986, whether or not the Receiver is an administrative receiver;
- 9.3.4 in relation to any Charged Property, which they would have if they were its only beneficial owner; and
- 9.3.5 to do all things incidental or conducive to any functions, powers, authorities or discretions conferred or vested in the Receiver.

**9.4 Receiver as agent**

The Receiver shall be the agent of the Chargor (which shall be solely liable for their acts, defaults, remuneration, losses and liabilities) unless and until the Chargor goes into liquidation, from which time they shall act as principal and shall not become the agent of the Security Trustee.

**9.5 Joint or several**

If two or more persons are appointed as Receivers of the same assets, they may act jointly and/or severally so that (unless any instrument appointing them specifies to the contrary) each of them may exercise individually all the powers and discretions conferred on Receivers by this Deed.

**9.6 Receiver's remuneration**

Every Receiver shall be entitled to remuneration for their services at a rate to be fixed by the Security Trustee and the maximum rate specified in section 109(6) of the Act shall not apply.

**10. APPLICATION OF MONEYS****10.1 Application of moneys**

All sums received by virtue of this Deed by the Security Trustee or any Receiver shall, subject to the payment of any claim having priority to this Deed, be paid or applied to the Secured Liabilities in such order as the Security Trustee may determine, and section 109(8) of the LPA shall not apply.

**11. POWER OF ATTORNEY****11.1 Appointment**

The Chargor irrevocably and by way of security appoints:-

11.1.1 the Security Trustee (whether or not a Receiver has been appointed);

11.1.2 any delegate or sub-delegate of, or other person nominated in writing by, an officer of the Security Trustee; and

11.1.3 (as a separate appointment) each Receiver,

severally as the Chargor's attorney and attorneys with power to do any act, and execute and deliver any deed or other document, on behalf of and in the name of the Chargor, which the Chargor could be required to do or execute under any provision of this Deed, or which the Security Trustee in its sole opinion may consider necessary or desirable for perfecting its title to any of the Charged Property or enabling the Security Trustee or the Receiver to exercise any of its rights or powers under this Deed.

**11.2 Ratification**

The Chargor ratifies and confirms and agrees to ratify and confirm whatever any attorney appointed pursuant to Clause 11.1 (*Appointment*) does or purports to do in the exercise or purported exercise of all or any of the powers, acts or other matters referred to in Clause 11.1 (*Appointment*).

**12. PROTECTION OF THIRD PARTIES****12.1 Statutory powers**

In favour of any purchaser, the statutory powers of sale and of appointing a Receiver which are conferred upon the Security Trustee, as varied and extended by this Deed, and all other powers of the Security Trustee, shall be deemed to arise (and the Secured Liabilities shall be deemed due and payable for that purpose) immediately after the execution of this Deed.

**12.2 Purchasers**

No purchaser from or other person dealing with the Security Trustee, any person to whom it has delegated any of its powers, or the Receiver, shall be concerned:-

- 12.2.1 to enquire whether any of the powers which the Security Trustee or a Receiver have exercised has arisen or become exercisable;
- 12.2.2 to enquire whether the Secured Liabilities remain outstanding or whether any event has happened to authorise the Receiver to act; or
- 12.2.3 as to the propriety or validity of the exercise of those powers,

and the title and position of a purchaser or such person shall not be impeachable by reference to any of those matters.

### **12.3 Receipts**

All the protection to purchasers contained in sections 104 and 107 of the LPA, section 42(3) of the Insolvency Act 1986 or in any other applicable legislation shall apply to any person purchasing from or dealing with the Security Trustee, any other Secured Party, any Receiver or any person to whom any of them have delegated any of their powers.

## **13. PROTECTION OF THE SECURED PARTIES AND ANY RECEIVER**

### **13.1 No liability**

None of the Security Trustee, the other Secured Parties, any Receiver or any of their respective officers, employees or delegates shall be liable in respect of any cost, liability, expense, loss or damage which arises out of the exercise, or attempted or purported exercise of, or the failure to exercise, any of their respective rights under this Deed.

### **13.2 Not mortgagee in possession**

Without prejudice to any other provision of this Deed, entry into possession of any Charged Property shall not render the Security Trustee, any Receiver or any of their respective officers or employees liable:-

- 13.2.1 to account as mortgagee in possession;
- 13.2.2 for any loss on realisation; or
- 13.2.3 for any default or omission for which a mortgagee in possession might be liable,

and if and whenever the Security Trustee or any Receiver enters into possession of any Charged Property it shall be entitled at any time it or they think fit to relinquish possession.

### **13.3 Indemnity**

The Chargor shall indemnify and keep indemnified the Security Trustee, each other Secured Party, any Receiver, and their respective officers, employees and delegates, against all claims, costs, expenses and liabilities incurred by them in respect of all or any of the following:-

- 13.3.1 any act or omission by any of them in relation to all or any of the Charged Property;
- 13.3.2 any payment relating to or in respect of all or any of the Charged Property which is made at any time by any of them;
- 13.3.3 any stamp, registration or similar Tax or duty which becomes payable in connection with the entry into, or the performance or enforcement of, this Deed;
- 13.3.4 exercising or purporting to exercise or failing to exercise any of the rights, powers and discretions conferred on them or permitted under this Deed;
- 13.3.5 any breach by the Chargor of any of its covenants or other obligations to the Security Trustee or any other Secured Party,

except in the case of gross negligence or wilful misconduct on the part of that person.

**13.4 Interest**

The Chargor shall pay interest at the Default Rate on the sums payable under this Clause 13 (*Protection of the Secured Parties and any Receiver*) from the date on which the liability was incurred to the date of actual payment (both before and after judgment).

**13.5 Indemnity out of the Charged Property**

The Security Trustee, the other Secured Parties, any Receiver and their respective officers, employees and delegates shall be entitled to be indemnified out of the Charged Property in respect of the actions, proceedings, demands, claims, costs, expenses and liabilities referred to in Clause 13.3 (*Indemnity*).

**13.6 Continuing protection**

The provisions of this Clause 13 (*Protection of the Secured Parties and any Receiver*) shall continue in full force and effect notwithstanding any release or discharge of this Deed or the discharge of any Receiver from office.

**14. PROVISIONS RELATING TO THE SECURITY TRUSTEE****14.1 Powers and discretions**

The rights, powers and discretions given to the Security Trustee in this Deed:-

- 14.1.1 may be exercised as often as, and in such manner as, the Security Trustee thinks fit;
- 14.1.2 are cumulative, and are not exclusive of any of its rights under the general law; and
- 14.1.3 may only be waived in writing and specifically, and any delay in exercising, or non-exercise of, any right, is not a waiver of it.

**14.2 Trusts**

The perpetuity period for any trusts constituted by this Deed shall be 125 years.

**15. PRESERVATION OF SECURITY****15.1 Continuing Security**

This Deed shall be a continuing security to the Security Trustee and shall remain in force until expressly discharged in writing by the Security Trustee notwithstanding any intermediate settlement of account or other matter or thing whatsoever.

**15.2 Additional Security**

This Deed is without prejudice and in addition to, and shall not merge with, any other right, remedy or Security of any kind which the Security Trustee or any other Secured Party may have now or at any time in the future for or in respect of any of the Secured Liabilities.

**15.3 Waiver of Defences**

Neither the Security created by this Deed nor the obligations of the Chargor under this Deed will be affected by an act, omission, matter or thing which, but for this Clause, would reduce, release or prejudice that Security or any of those obligations (whether or not known to it, the Security Trustee or any other Secured Party) including:-

- 15.3.1 any time, waiver or consent granted to, or composition with, any Obligor or other person;
- 15.3.2 the release of any Obligor or any other person under the terms of any composition or arrangement with any person;
- 15.3.3 the taking, variation, compromise, exchange, renewal, enforcement or release of, or refusal or neglect to perfect, take up or enforce, any rights against, or Security over, assets of any Obligor or other



person or any non-presentation or non-observance of any formality or other requirement in respect of any instrument or any failure to realise the full value of any Security;

- 15.3.4 any incapacity or lack of power, authority or legal personality of or dissolution or change in the members or status of any Obligor or any other person;
- 15.3.5 any amendment (however fundamental), replacement, variation, novation, assignment or the avoidance or termination of a Finance Document or any other document or Security;
- 15.3.6 any unenforceability, illegality or invalidity of any obligation of, or any Security created by, any person under any Finance Document or any other document; or
- 15.3.7 an insolvency, liquidation, administration or similar procedure.

#### 15.4 Immediate recourse

The Chargor waives any right it may have of first requiring any Secured Party (or any trustee or agent on its behalf) to proceed against or enforce any other rights of Security or claim payment from any person before claiming from the Chargor under this Deed. This waiver applies irrespective of any law or any provision of a Finance Document to the contrary.

#### 15.5 Appropriations

During the Security Period each Finance Party may:-

- 15.5.1 refrain from applying or enforcing any monies, Security or rights held or received by it (or any trustee or agent on its behalf) in respect of the Secured Liabilities, or, subject to Clause 10.1 (*Application of moneys*), apply and enforce the same in such manner and order as it sees fit (whether against the Secured Liabilities or otherwise) and the Chargor shall not be entitled to the same; and
- 15.5.2 hold in an interest-bearing suspense account any moneys received from the Chargor on or account of the Secured Liabilities.

#### 15.6 New Accounts

If the Security Trustee or any other Secured Party receives notice (whether actual or otherwise) of any subsequent Security over or affecting any of the Charged Property or if a petition is presented or a resolution passed in relation to the winding up of the Chargor, it may close the current account or accounts and/or open a new account or accounts for the Borrower. If the Security Trustee or any other Secured Party does not open a new account or accounts immediately it shall nevertheless be treated as if it had done so at the time when the relevant event occurred, and as from that time all payments made by the Borrower to that Finance Party shall be credited or be treated as having been credited to the new account or accounts and shall not operate to reduce the Secured Liabilities.

#### 15.7 Tacking

For the purposes of section 94(1) of the LPA and section 49(3) of the Land Registration Act 2002 the Security Trustee confirms on behalf of the Lender that the Lender shall make further advances to the Borrower on the terms and subject to the conditions of the Finance Documents.

#### 15.8 Deferral of Chargor's rights

During the Security Period and unless the Security Trustee otherwise directs, the Chargor shall not exercise any rights which it may have by reason of performance by its obligations under this Deed or the enforcement of the Security created by this Deed:-

- 15.8.1 to receive or claim payment from, or be indemnified by an Obligor;
- 15.8.2 to claim any contribution from any guarantor of, or provider of Security in respect of, any Obligor's obligations under the Finance Documents;
- 15.8.3 to take the benefit (in whole or in part and whether by way of subrogation or otherwise) of any rights of any Secured Party under any Finance Document or of any guarantee or Security taken pursuant to, or in connection with, the Finance Documents by any Secured Party;

15.8.4 to exercise any right of set-off against any Obligor; and/or

15.8.5 to claim or prove as a creditor of any Obligor in competition with any Secured Party.

## **16. RELEASE**

### **16.1 Release**

Upon the irrevocable and unconditional payment and discharge in full of the Secured Liabilities and the termination of all facilities which might give rise to Secured Liabilities, the Security Trustee shall, or shall procure that its appointees will, at the request and cost of the Chargor:-

16.1.1 release the Charged Property from this Deed; and

16.1.2 re-assign the Charged Property that has been assigned to the Security Trustee under this Deed.

### **16.2 Reinstatement**

If the Security Trustee considers that any amount paid or credited to any Secured Party under any Finance Document (whether in respect of the obligations of any Obligor or any Security for those obligations or otherwise) is capable of being avoided, reduced or otherwise set aside:-

16.2.1 that amount shall not be considered to have been paid for the purposes of determining whether the Secured Liabilities have been irrevocably and unconditionally paid and discharged; and

16.2.2 the liability of the Chargor and the Security created by this Deed shall continue as if that amount had not been paid or credited.

### **16.3 Consolidation**

Section 93 of the LPA dealing with the consolidation of mortgages shall not apply to this Deed.

## **17. MISCELLANEOUS PROVISIONS**

### **17.1 Severability**

If any provision of this Deed is illegal, invalid or unenforceable in any jurisdiction, that shall not affect:-

17.1.1 the validity or enforceability of any other provision, in any jurisdiction; or

17.1.2 the validity or enforceability of that particular provision, in any other jurisdiction.

### **17.2 Amendments and variations**

This Deed shall remain in full force and effect notwithstanding any amendment, restatement, novation or supplementation of the Finance Documents (including any increase in the amount of the Secured Liabilities).

### **17.3 Remedies and waivers**

No failure to exercise, nor any delay in exercising, on the part of the Security Trustee, any right or remedy under this Deed shall operate as a waiver, nor shall any single or partial exercise of any right or remedy prevent any further or other exercise or the exercise of any other right or remedy. The rights and remedies provided in this Deed are cumulative and not exclusive of any rights or remedies provide by law.

### **17.4 Counterparts**

This Deed may be executed in any number of counterparts, and this has the same effect as if the signatures on the counterparts were on a single copy of this Deed.

## **18. GOVERNING LAW**

This Deed and any non-contractual obligations arising out of or in connection with it are governed by English law.

**19. ENFORCEMENT**

**19.1 Jurisdiction of English Courts**

- 19.1.1 The courts of England have exclusive jurisdiction to settle any dispute arising out of or in connection with this Deed (including a Dispute regarding the existence, validity or termination of this Deed or any non-contractual obligations arising out of or in connection with this Deed) (a "**Dispute**").
- 19.1.2 The Parties agree that the courts of England are the most appropriate and convenient courts to settle Disputes and accordingly no Party will argue to the contrary.
- 19.1.3 This Clause 19.1 (*Jurisdiction of English Courts*) is for the benefit of the Secured Parties only. As a result, no Secured Party shall be prevented from taking proceedings relating to a Dispute in any other courts with jurisdiction. To the extent allowed by law, the Secured Parties may take concurrent proceedings in any number of jurisdictions.
