1. Introduction, background and circumstances giving rise to the appointment

Introduction

At 4 pm on 8 April 2009 the Company entered administration and C P Dempster and F L Taylor were appointed to act as Joint Administrators. This document, including its appendices, constitutes the Joint Administrators' statement of proposals to creditors pursuant to paragraph 49 of Schedule B1 to the Insolvency Act 1986 and Rule 2.33 of the Insolvency Rules 1986.

Certain statutory information relating to the Company and the appointment of the Joint Administrators is provided at Appendix A.

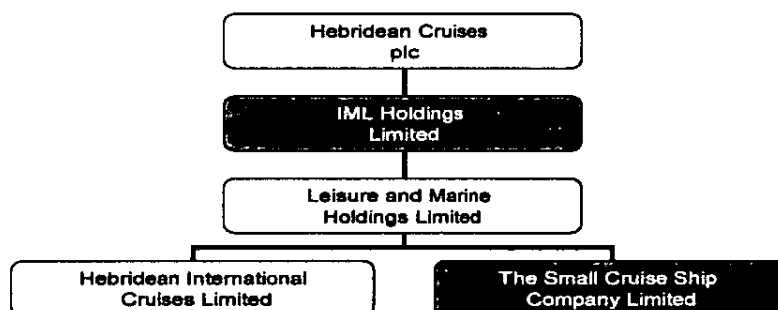
Background

The Company was incorporated in 1988 and had become known for offering luxury cruises around the Western Isles of Scotland aboard its flagship, the Hebridean Princess ("the Princess"), and further afield on the Hebridean Spirit ("the Spirit") which cruised international waters. Both ships were owned by the Company's parent company, Leisure and Marine Holdings Limited.

The organisation chart below depicts the group structure of the business.

Hebridean International Cruises Limited and Leisure and Marine Holdings Limited entered administration on 8 April 2009 while Hebridean Cruises plc entered administration on 24 April 2009.

Both IML Holdings Limited and The Small Cruise Ship Company Limited are considered to be dormant entities.



The recent financial results of Hebridean International Cruises Limited can be summarised as follows:

We are currently not aware of any transactions between the Company and connected parties in the two years prior to the Company entering administration. However, the Joint Administrators are required to submit a report to the Department for Business Enterprise and

Regulatory Reform regarding the conduct of the directors of the Company. Should we discover such transactions during the course of our investigations then these shall be investigated fully.

Circumstances Giving Rise to the Appointment of the Administrators

During the course of the 2008 season, the trading performance of the Spirit prompted the board of directors to review the future of this half of the business. In late 2008, the directors took the decision to seek a purchaser for the Spirit either on a going concern basis or as a stand alone asset. The directors considered that the best offer was received from an individual who wished to convert the ship for use as a private yacht. The sale was announced in March 2008 and customers of the Spirit were advised that future cruises would no longer be taking place.

Although the directors sought the approval of secured creditors to dispose of the Spirit, they did not reach agreement regarding the ongoing funding arrangements for the remaining business. The sale of the Spirit was completed on 7 April 2009 and, in the absence of an agreement on future funding, the Bank issued demands on the Company's ultimate parent company, Hebridean Cruises plc, for the amounts which remained outstanding to them following the sale. As guarantor for the lending, the Company also received a notice of demand.

The board of directors held a meeting on 8 April 2009 and resolved to request that the Bank appoint administrators to the Company and to its parent company, Leisure and Marine Holdings Limited ("LMH").

2. Purpose, conduct and end of administration

Purpose of the Administration

The purpose of an administration is to achieve one of three objectives:

- a. To rescue the company as a going concern
- b. To achieve a better result for the company's creditors as a whole than would be likely if the company were wound up (without first being in administration)
- c. To realise property in order to make a distribution to one or more secured or preferential creditors

Insolvency legislation provides that objective (a) should be pursued unless it is not reasonably practicable to do so or if objective (b) would achieve a better result for the company's creditors as a whole. Objective (c) may only be pursued if it is not reasonably practicable to achieve either objective (a) or (b) and can be pursued without unnecessarily harming the interests of the creditors of the company as a whole.

We did not consider that objective (a) was achievable as a result of the significant levels of debt of the Company. In particular, the Company had received c£5m of advance payments from customers for cruises on the Princess. In the event that the Company was rescued as a going concern, these advance payments would have to be honoured therefore any potential purchaser would be faced with a significant shortfall in revenue. Consequently, we did not believe that this was a viable option.

Objective (b) is being pursued, however due to the substantial debt owed to the secured creditors it is unlikely that the ordinary unsecured creditors will receive a distribution other than by virtue of the prescribed part, if applicable.

In any case, we consider that the pursuit of objective (c) would not harm the interests of the creditors of the Company as a whole. As a result of our administration strategy, outlined below, we were able to secure a transfer of the majority of employees to the new purchaser under TUPE thus reducing the level of preferential creditors. As regards the ordinary unsecured creditors of the Company, the level of secured debt was considerably in excess of the value of the Company's assets therefore there is no prospect of a recovery for this class of creditors.

Conduct of the Administration

Trading

As previously advised, the Joint Administrators were appointed at 4 pm on 8 April 2009. The Princess was due to dock at Oban the following morning and depart on a new cruise later that same day. In order to continue to run the scheduled cruise, the Joint Administrators would have to provide guarantees to settle a significant quantum of payments including ongoing crew and employee wages, fuel, harbour charges, food and drink and insurance (which terminated as a result of our appointment). As a practical matter we would also have to pay arrears of wages for the crew in order to ensure their co-operation.

Neither the Joint Administrators nor the Company had any means of funding these commitments.

Due to a lack of funding, the Joint Administrators had to consider the immediate cancellation of all future cruises (including the departure on 9 April 2009) and to proceed with storing the ship at harbour. Due to the risk that a large number of creditors may have attempted to arrest the ship, the Joint Administrators would have had to relocate the Princess from Oban to a neutral harbour in England. It was envisaged that the vessel would be sold by a formal auction process which could have taken considerable time to complete. During this period,

the business would have ceased to trade immediately, all employees (both on the vessel and at head office) would have been made redundant and all future cruises cancelled.

However, on the day of our appointment, we were approached by a trade buyer who had been in discussions with the Company's directors in the period leading up to our appointment. They demonstrated a detailed knowledge of the Princess and the current business and were therefore in a position to complete a purchase within a short timeframe thereby preserving the Princess brand. The potential purchaser agreed to make an immediate non-refundable payment to the administrators to fund the business for a 2 week period, including the cruises of the Princess due for departure on 9 April 2009 and 16 April 2009, in return for a 2 week exclusivity period to negotiate a sale of the business and its assets.

The administrators were of the opinion that this proposal would lead to a better outcome for creditors than cancelling the cruises, which would have damaged the brand and therefore the value of the business and its assets, and selling the vessel at auction.

The Company was already in redundancy consultations with a number of employees aligned to the Spirit business. Following our appointment, we reviewed the roles of all employees and made a total of 10 people redundant in order to reflect the closure of the Spirit business.

In order to protect the value of the business, we continued to take booking enquiries during the trading period although we did not accept any customer deposits.

Sale of the Business and or Assets

On 22 April 2009 the Joint Administrators completed a sale of the business and assets of the Company and LMH to All Leisure Holidays Limited ("ALHL") for a total consideration of £1.36m.

The price paid reflects two significant issues.

Firstly, as stated previously, approximately £5m of advance payments had been received by the Company from customers in respect of future Princess cruises. These funds were not kept in a separate account and were applied against the Company's borrowings. As a result, any purchaser wishing to run the remainder of the 2009 Princess cruise programme and the 2010 programme with the existing customers would have been faced with a significant shortfall in revenue. Effectively, this has eroded the value of the goodwill of the business.

Secondly, the Princess requires a significant overhaul this winter to remove asbestos in order to maintain its certifications as a SOLAS compliant cruise liner. Management estimates the cost of this to be in the region of £600,000.

Further information regarding the transaction is given below.

As detailed above, the Joint Administrators believed that entering into an exclusivity period with the purchaser immediately following their appointment represented the best method of preserving value for the creditors of the Company. During the exclusivity period, the Joint Administrators continued to note the interests of a number of interested parties in the event that a sale could not be completed with ALHL.

Prior to concluding the sale to ALHL, we assessed the alternative outcome for creditors. Given that all cruises would have been cancelled, we would have been selling assets on a break up basis.

The Joint Administrators were provided with a copy of a valuation of the Princess carried out on behalf of the Bank by a reputable shipbroker in January 2009. This valuation, on the basis of a sale of the vessel as a stand alone asset, was \$2m - \$2.5m (c£1.4m - c£1.7m).

However, it should be noted that the valuation of the Princess was carried out without inspection of the ship or its classification records. The valuation was also based on the

assumption that the ship was SOLAS 2010 compliant. Consequently, the costs which would need to be incurred for removing the asbestos (estimated at £600k) were not taken into consideration. Additionally, we estimate that the costs of transferring the vessel to another port, arresting it and selling it through a formal auction process would be at least £200k. A realistic estimate as to what could be expected in a sale on a break up basis is therefore c£600k – c£900k.

Consultations were held with the Bank who holds a mortgage in relation to the Princess and a debenture over the remaining assets of the Company and LMH before the offer was accepted. The key suppliers which were being used during the exclusivity period and the employees of the Company were kept informed of the progress of our negotiations with ALHL, albeit on a confidential basis.

We also instructed Thainstone Specialist Auctions to value the assets (excluding the Princess) of the Company and LMH.

The assets sold comprise the following:

The transaction was completed as a sale of the business and assets of the Company and LMH. The consideration of £1m has been paid in full. A further £300k was provided as a non-refundable payment on 9 April 2009 to enable the Company to continue to trade whilst negotiations took place with ALHL. On 21 April 2009, a further £60k was provided for further costs of trading the business.

The sale proceeds shall be apportioned in accordance with the provisions of the fixed and floating charges. Due to some complexities in this particular case, the Joint Administrators are currently awaiting the outcome of a legal review of the relevant security documentation to ensure that the sale proceeds are apportioned correctly.

As far as the Joint Administrators are aware, none of the directors of the Company or LMH have given any personal guarantees in respect of the Company's debts.

Asset Realisations

The Company owns 4 cars, with a book value of £31,729, which were not included in the sale to ALHL. It is intended that these cars will be sold at auction shortly.

There are also a number of prepayments which the Company has made for services not provided, such as insurance policies which terminated on appointment. The Joint Administrators are endeavouring to have these amounts refunded where possible.

The VAT return for the period up to the appointment of the Joint Administrators has been submitted showing a repayment of £48,392 due to the Company. We have yet to receive confirmation that HMRC will settle this amount without offset.

Customer deposits

Hebridean Spirit

In March 2009, the directors of the Company notified customers of the Spirit that this vessel was to be sold to an undisclosed buyer. The directors informed these customers that they would refund their deposits once the sale of the vessel had been completed.

However, as stated previously, the funds received from the sale of the Spirit were applied to settle some of the Company's secured debt. Consequently, the Company is no longer in a financial position to refund customer deposits in respect of the Spirit.

Customers may be aware that the terms and conditions contained in the Company's cruise brochures state that one of the key provisions of The Package Travel Holidays and Package Tours Regulations 1992 ("the Regulations"), under Regulations 17 to 21, 'is that arrangements must be made to secure monies paid in advance by a passenger'. The Regulations provide that such arrangements can take a number of forms including bonding, insurance or monies in trust.

In accordance with Regulation 16(2) of the Regulations, packages which are covered by the ATOL licence do not require arrangements under Regulations 17 to 21 to be in place due to the nature of the protection provided by ATOL. ATOL protection covers the whole cost of holiday packages with a flight element (i.e. not only the flight itself). Hebridean Spirit cruises with a flight element are considered to be within the protection of the ATOL.

The Joint Administrators have advised all customers who remitted funds to the Company prior to the administration in respect of a Spirit cruise that they should contact ATOL to initiate a claim for their cancelled cruise. ATOL can be contacted directly on 020 7453 6350 between 9am to 5pm Monday to Friday or, alternatively, on their website at www.caa.co.uk

Hebridean Princess

Following the sale to ALHL, we understand that the purchaser has made a commercial decision to continue the current cruise programme of the Hebridean Princess, under the name of Hebridean Island Cruises. As the operation of the cruises is now being undertaken by ALHL, customers have been requested to confirm to the purchaser that they wish to continue the cruise under the new operation.

Customers of the Princess should note that, as detailed above, the Company no longer held any funds in respect of customer deposits for bookings made with HICL on the Hebridean Princess prior to the Administration of the Company. Customers will therefore be required to claim their initial booking from the Company's financial failure insurance provider, International Passenger Protection Limited ("IPP"). Customers should contact IPP directly on +44 (0)20 8776 3752 to register their claim or visit their website at www.ipplondon.co.uk. This insurance is considered to be an appropriate policy in terms of the Regulations.

The Company sold some Princess cruise packages which included a flight element. Those customers who remitted funds in respect of a booking on the Princess before the Administration of the Company which included a flight element within their booking should contact ATOL directly on 020 7453 6350 between 9am to 5pm Monday to Friday or visit the website at www.caa.co.uk in order to register their claim.

All Customers

All customers of the Company should also check their travel insurance policy as it may provide cover for a cancellation. The type of cover provided will vary according to the type of policy taken out. Your policy may cover the complete or partial cost of the original booking purchased.

If you paid by credit card, you may also be protected by Section 75 of the Consumer Credit Act 1974. You should check with your credit card provider for further advice.

Initial Meeting of Creditors

The Joint Administrators are of the opinion that the Company has insufficient property to enable a distribution to be made to unsecured creditors other than by virtue of the prescribed part and consequently, in accordance with the provisions of paragraph 52(1) of Schedule B1 to the Act, they do not intend to call an initial creditors' meeting.

The Joint Administrators will be obliged to call an initial meeting of creditors if it is requested by creditors of the Company whose debts amount to at least 10% of the total debts of the Company. The request must be made within 12 days of the date on which these proposals are sent out (or such longer period as the court may allow) and must be in the prescribed form. The creditor summoning the meeting must lodge with the Joint Administrators a deposit as security for the expenses of summoning and holding the meeting. Further information is provided in the covering letter accompanying these proposals.

Future Conduct of the Administration

The Joint Administrators intend to proceed as detailed above in order to realise the remaining assets of the Company.

In terms of the Company Directors Disqualification Act 1986, the Joint Administrators are required to prepare a report on those individuals who have been directors or shadow directors of the Company in the three year period prior to our appointment. If any creditors are aware of any matter which they believe should be brought to our attention, then they should write to us giving appropriate details.

The End of the Administration

CVL

Should there be property available which might permit a distribution to the unsecured creditors at the end of the Administration, it is proposed that the Company will move straight into Creditors' Voluntary Liquidation upon the filing with the registrar of companies of a notice pursuant to paragraph 83 of Schedule B1 to the Insolvency Act 1986. It is proposed that the Liquidators will be C P Dempster and F L Taylor of Ernst & Young LLP. In accordance with paragraph 83(7) of Schedule B1 to the Insolvency Act 1986 and Rule 2.117(3) of the Insolvency Rules 1986, creditors may nominate a different person as the proposed liquidator, provided that the nomination is made after the receipt of these proposals and before the proposals are approved. It should be noted in this regard that a person must be authorised to act as an insolvency practitioner in order to be appointed as liquidator.

DISSOLUTION

Should there be no property which might permit a distribution to the unsecured creditors at the end of the Administration, it is proposed that the Joint Administrators will send a notice to that effect to the Registrar of Companies. On registration of the notice the Joint Administrators' appointment will come to an end. In accordance with the provisions of paragraph 84(6) of Schedule B1 to the Insolvency Act 1986 the Company will be deemed to be dissolved three months after the registration of the notice.

3. Statement of affairs

A Statement of Affairs as at 8 April 2009 has been submitted and signed by one of the directors. We are currently awaiting statements of concurrence from the other directors. A summary is attached at Appendix B. We would stress that this summary has been prepared by the directors and not the Joint Administrators. A number of creditor claims have yet to be quantified and may be higher than indicated. Additionally, the values are shown before applicable costs of realisation.

We provide below, for information, an indication of the current position with regard to creditors' claims. The figures have been compiled by Company management and have not been subject to independent review or statutory audit.

Secured Creditors

According to the Directors' Statement of Affairs, at 8 April 2009, Hebridean Cruises plc, the Company's ultimate parent company, had debts of £1,691,350 owing to Bank of Scotland plc. The Company cross guaranteed this debt and this is secured by way of a mortgage over the Princess and a debenture including a fixed and floating charge over the assets of the Company.

Stonefield Castle Group Limited is owed £2m by Hebridean Cruises plc. The Company cross guaranteed this debt and this is secured by a second ranking floating charge over the assets of the Company.

Preferential Creditors

We currently estimate preferential creditors of £7,908 in respect of claims for employees' salaries, holiday pay and pension contributions. This was reduced considerably from the date of our appointment as the majority of employees were retained and transferred to All Leisure Holidays Limited under TUPE.

Ordinary unsecured Creditors

These creditor claims continue to be submitted. It is estimated that total ordinary unsecured claims will be in the region of £12m, although this figure includes c£9.2m of customer deposits which should mostly be recoverable from ATOL or IPP.

4. Prescribed part

The prescribed part is a proportion of floating charge assets set aside for unsecured creditors pursuant to section 176A of the Insolvency Act 1986. The prescribed part applies to floating charges created on or after 15 September 2003.

As previously mentioned, the proceeds from the realisation of the Company's assets shall be apportioned in accordance with the provisions of the fixed and floating charges. Due to some complexities in this particular case, the Joint Administrators are currently awaiting the outcome of a legal review of the relevant security documentation to ensure that the sale proceeds are apportioned correctly.

Therefore, the Joint Administrators currently estimate, to the best of their knowledge and belief, that

- ▶ the value of the prescribed part is nil, and
- ▶ the value of the Company's net property is nil.

At present we are of the opinion that, should there be a prescribed part following the review of the Company's securities, it is likely to be of nominal value. In addition, the adjudication of the potentially high volume of creditors' claims is likely to be more costly than the value of the prescribed part itself. Consequently the Joint Administrators are likely to make an application to the court, under section 176A(5) of the Insolvency Act 1986 for an order not to distribute the prescribed part on the grounds that the cost of making a distribution to unsecured creditors would be disproportionate to the benefits.

5. Administrators' remuneration and disbursements and payments to other professionals

Remuneration

The statutory provisions relating to remuneration are set out in Rule 2.106 of the Insolvency Rules 1986. Further information is given in the Association of Business Recovery Professionals' publication 'A Creditors' Guide to Administrators' Fees', a copy of which may be accessed from the web site of the Insolvency Practitioners Association at <http://www.insolvency-practitioners.org.uk> (follow 'Regulation and Guidance' then 'Creditors' Guides to Fees'), or is available in hard copy upon written request to the Joint Administrators.

As the Joint Administrators have made a statement under paragraph 52(1)(b) of schedule B1 of the Insolvency Act 1986, their remuneration and Category 2 disbursements will be agreed with the secured creditors and the preferential creditors in accordance with the provisions of Rule 2.106(5A) of the Insolvency Rules 1986. The Joint Administrators propose that their remuneration be fixed on the basis of time properly given by them and their staff in dealing with matters arising in the Administration. Attached at Appendix C is a table of the current charge out rates for each grade of staff, as required by the Association of Business Recovery Professionals' Statement of Insolvency Practice No. 9.

Disbursements

Appendix C also includes a statement of the Joint Administrators' policy for charging disbursements. In the event that a Creditors' Committee is not formed, the Joint Administrators propose they be permitted to charge disbursements in accordance with the charging policy set out in Appendix C.
