Statement of circumstances in accordance with Section 519 of the Companies Act 2006

In accordance with our responsibilities under Section 519 of the Companies Act 2006, we are writing to confirm that we are resigning as auditors at the request of the board of directors of the company on account of concerns raised by the directors in connection with an alleged fraud in the company. These concerns have not been explained to us other than that the total amount involved is substantial.

However, we are not in a position to confirm this due to the unspecified nature of the concerns raised.
