REPORT OF THE DIRECTORS

The directors submit their report and the audited financial statements for the year ended 31st December 1995.

PRINCIPAL ACTIVITY

The principal activity of the company during the year was that of an investment holding company.

RESULTS AND DIVIDENDS

The results for the year are detailed in the profit and loss account on page 4 and show a profit before tax of £10,837,120 (1994:£4,211,971). An interim dividend of £4,664,904 was paid (1994: £Nil). No final dividend is proposed for the year ended 31st December 1995 (1994: £Nil) leaving a profit of £4,382,730 (1994: £4,235,148) to be transferred to reserves.

STATEMENT OF DIRECTORS' RESPONSIBILITIES IN RELATION TO FINANCIAL STATEMENTS

The following statement, which should be read in conjunction with the statement of auditors' responsibilities set out on page 3, is made with a view to distinguishing for shareholders the respective responsibilities of the directors and of the auditors in relation to the financial statements.

The directors are required by the Companies Act 1985 to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the company and its subsidiaries as at the end of the financial year and of the profit or loss for the financial year. The directors are required to prepare the financial statements on the going concern basis unless it is not appropriate.

The directors consider that in preparing the financial statements on pages 4 to 9, the company has used appropriate accounting policies, consistently applied and supported by reasonable and prudent judgements and estimates, and that all accounting standards which they consider to be applicable have been followed.

The directors have responsibility for ensuring that the company keeps accounting records which disclose with reasonable accuracy the financial position of the company and which enable them to ensure that the financial statements comply with the Companies Act 1985.

The directors have general responsibility for taking such steps as are reasonably open to them to safeguard the assets of the group and to prevent and detect fraud and other irregularities.





The financial statements have been prepared in accordance with applicable accounting standards. Investments in subsidiary undertakings are stated at the lower of cost and underlying net asset value.

2. CREDIT IN RESPECT OF AMOUNTS DUE FROM SUBSIDIARY UNDERTAKINGS

A credit of £7,178,453 (1994: £2,147,865) has been made against amounts owed by a subsidiary undertaking. The credit reflects the recovery of interest of £3,248,847 previously provided for and the write up of the balance recoverable of £7,346,920 (1994 : £3,417,344) being the company's share of the net assets of the subsidiary.
