**1) Introduction**

**2) Receipts and Payments**

**3) Progress of the Liquidation**

I have received tax clearance from HM Revenue and Customs and I will therefore take steps to conclude the liquidation.

**4) Members’ Rights**

Within 21 days of the receipt of this report, members with either at least 5% of the total voting rights of all the members having the right to vote at general meetings of the Company or with the permission of the court, may request in writing that the Liquidator provide further information about his remuneration or expenses which have been itemised in this progress report.

**4) Next Report**

I am required to provide a further report on the progress of the liquidation within two months of the end of the third anniversary of the liquidation, however, as I intend to conclude matters prior to this, I will write to all members with my final progress report and convene the final meeting of members.
