- THAT the directors be generally and unconditionally authorised with immediate effect for the purposes of section 80 of the Companies Act 1985 to allot relevant securities (as defined in that section) comprising the Ordinary Shares and the Preference Shares at any time or times during the period expiring at the end of five (5) years from the date on which this resolution is passed provided that the Company may before such expiry make an offer or agreement which would or might require relevant securities to be allotted after such expiry and the directors may allow relevant securities in pursuance of such offer or agreement as if the authority conferred by this resolution had not expired.
