- (B) "Executive Directors", who may be appointed by the Board, subject to confirmation by the members in annual general meeting, in accordance with Article 38. Only employees of the Company shall be appointed to be Executive Directors. Any Executive Director who ceases to be an employee of the Company for any reason shall automatically cease to be a Director on ceasing to be an employee."
