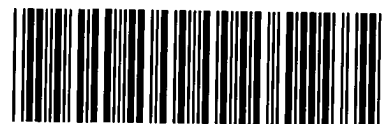

**Small company exemption**





**1. Accounting Policies**

**General information**

The Company is a private company limited by shares and is incorporated and domiciled in England and Wales, registration number 02263785. The address of its registered office is Level 5, 9 Hatton Street, London NW8 8PL.

**Basis of preparation**

The individual financial statements of Strong & Fisher Pensions and Retirement Scheme Trustees Limited have been prepared under the historical cost convention in compliance with the provisions of FRS 102 Section 1A - Small Entities, the Financial Reporting Standard applicable in the UK and the Republic of Ireland and the Companies Act 2006.

The financial statements are presented in Sterling and rounded to the nearest thousand.

**2. Income statement**

No income statement is presented with these financial statements because the Company has not received income, incurred expenditure or recognised any gains or losses during either the year under review or the preceding financial year.
