REPORT OF THE INDEPENDENT AUDITORS TO THE MEMBERS OF JEFFREY MCCALL ASSOCIATES LIMITED

Opinion

We have audited the financial statements of Jeffrey McCall Associates Limited (the 'company') for the year ended 24 June 2019 which comprise the Income Statement, Balance Sheet and Notes to the Financial Statements, including a summary of significant accounting policies.
