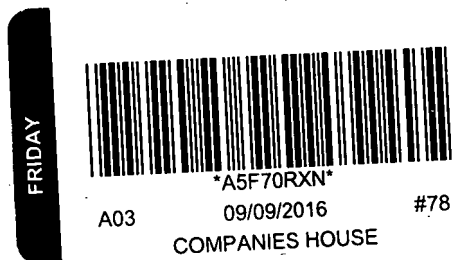

For the year ending 31 December 2015 the company was entitled to exemption under section 480 of the Companies Act 2006 relating to dormant companies.


The members have not required the company to obtain an audit in accordance with section 476 of the Companies Act 2006.

Basis of accounting

The financial statements have been prepared in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2009)

Going Concern

The company has net liabilities at the balance sheet date. Notwithstanding this, the directors believe that it is appropriate to adopt the accounts on a going concern basis in the preparation of the financial statements due to the support provided to the company by Bollin Group Limited, the ultimate parent undertaking.

Cash flow statement
