The declaration of solvency, sworn by the directors prior to the commencement of the liquidation, showed a debt due from William Hill Organization Limited The debt has been distributed by assignment to The Regal Sunderland Stadium Limited, the Company's sole shareholder (see "Distributions" below)

The Company had no known creditors A notice to creditors to prove their claims in the liquidation was advertised in The London Gazette newspaper on 18 September 2012 No creditors were forthcoming as a result of this advertisement

#### Tax

The Company's tax advisors advised that the Company had dormant corporation tax status Following their appointment, the joint liquidators sought and received confirmation from HM Revenue and Customs ("HMRC") that the Company had no outstanding corporation tax returns or liabilities, that it would not raise enquiries into any pre or post liquidation periods and that it had no objection to the liquidators calling a final meeting of members to conclude the liquidation

A similar assurance was sought and received from HMRC in respect of PAYE and VAT matters

#### **Distributions**

On 19 March 2013 the joint liquidators declared a first and final distribution of the assets of the Company to The Regal Sunderland Stadium Limited

The distribution was at the rate of £1 per £1 Ordinary share and was effected by assignment of the debt of £600,000 due to the Company from William Hill Organization Limited
