THEY CARRY RIGHTS TO RECEIVE DIVIDENDS AND HAVE CAPITAL DISTRIBUTION RIGHTS, BOTH OF WHICH ARE SENIOR TO THOSE OF THE ORDINARY SHARES. AS REGARDS DIVIDENDS, THEY ARE ENTITLED TO A DIVIDEND EQUAL TO ONE-THIRD OF THE PROFITS BY LAW AVAILABLE FOR DISTRIBUTION PROVIDED THAT IF SUCH DIVIDEND SHALL EXCEED 10% OF THE AMOUNTS FOR THE TIME BEING PAID UP OR CREDITED AS PAID UP ON THE REDEEMABLE PREFERENCE SHARES THE DIVIDEND SHALL BE LIMITED TO 10%.
