Directors' responsibilities



INDEPENDENT AUDITORS' REPORT TO THE MEMBERS OF JCB DUMP TRUCKS LIMITED

We have audited the financial statements of JCB Dump Trucks Limited for the year ended 31 December 2007. These financial statements have been prepared in accordance with the accounting policies set out therein.


