Except as noted above, all Directors served throughout the year and are still Directors at the date of this report.


Qualifying third party indemnity provisions


For the year ended 30 September 2018 the Company was entitled to exemption from audit under section 480 of the Companies Act 2006.

1. Accounting policies

1.1 Basis of preparation of financial statements

The financial statements have been prepared under the historical cost convention in accordance with Financial Reporting Standard 102, the Financial Reporting Standard applicable in the UK and the Republic of Ireland ("FRS 102") and the Companies Act 2006.

2. Profit and loss account

No profit and loss account has been prepared as the Company has not traded during the period and has made neither profit nor loss.

The Directors did not received any emoluments in respect of their services during the period.
