# AMSPROP LONDON LIMITED

#### PRELIMINARY

- 1. (a) The Regulations contained in Table A in the Schedule to the Companies (Tables A to F) Regulations-1985 as amended by the Companies (Tables A to F) (Amendment) Regulations 1985 (such Table being hereinafter called "Table A") shall apply to the Company save in so far as they are excluded or varied hereby and such Regulations (save as so excluded or varied) and the Articles hereinafter contained shall be the regulations of the Company.
- (b) In these Articles the expression "the Act" means the Companies Act 1985, but so that any reference in these Articles to any provision of the Act shall be deamed to include a reference to any structury modification or re-enactment of that provision for the time being in force.

## ALLOTMENT OF SHARES

- 2. (a) Shares which are comprised in the authorised share capital with which the Company is incorporated shall be under the control of the Directors who may (subject to Section 30 of the Act and to paragraph (d) below) affor, grant options over or otherwise dispose of the same, to such persons, on such terms and in such manner as they think fit.
- (b) All shares which are not comprised in the authorised share capital with which the Company is incorporated and which the Directors propose to issue shall first be offered to the Members in proportion as nearly as may be to the number of the existing shares held by them respectively unless the Company in General Meeting shall by Special Resolution otherwise direct. The offer shall be made by notice specifying the number of shares offered, and limiting a period (not being less than fourteen by notice specifying the number of shares offered, will be deemed to be declined. After the expiration of days) within which the offer, if not accepted, will be deemed to be declined. After the expiration of that period, those shares so deemed to be declined shall be offered in the proportion storesaid to the persons who have, within the said period, accepted all the shares offered to them; such further offer shall be made in like terms in the same manner and limited by a like period as the original offer. Any shall be made in like terms in the same manner and limited by a like period as the original offer. Any shares not accepted pursuant to such offer or further offer as aloresaid or not capable of being offered as aforesaid except by way of tractions and any shares released from the provisions of this.

Article by any such Special Resolution as aloresaid shall be under the control of the Directors, who may allot, grant options over or etherwise dispose of the same to such persons, on such terms, and in such manner as they think fit, provided that, in the case of shares not accepted as aforesaid, such shares shall not be disposed of on terms which are more tavourable to the subsoribers therefor than the terms on which they were offered to the Members. The foregoing provisions of this paragraph (b) shall have effect qubject to Section 80 of the Act.

(c) in accordance with Section \$1(1) of the Act Sections 89(1) and 90(1) to (6) (inclusive) of the Act shall not apply to the Company

(d) The Directors are generally and unconditionally authorised for the purposes of Section 80 of the Act, to exercise any power of the Company to allot and grant rights to subscribe for or convert securities into shares of the Company up to the amount of the authorised share capital with which the Company is incorporated at any time or times during the period of five years from the date of incorporation and the Directors may, after that period, allot any shares or grant any such rights under incorporation and the Directors may, after that period, allot any shares or grant any such rights under incorporation in pursuance of an offer or agreement so to do made by the Company within that period, this authority hereby given may at any time (subject to the said Section 80) be renewed, revoked or varied by Ordinary Resolution of the Company in General Meeting.

- 3 The lien conferred by Clause 8 in Table A shall attach also to fully paid-up shares, and the Company shall also have a first and paramount lien on all shares, whether fully paid or not, standing registered in the name of any person indebted or undor liebility to the Company, whether he shall be one of two or more joint holders, for all moneys presently payable by him or his estate to the Company. Clause 8 in Table A shall be modified accordingly.
  - 3A1 The issued share capital of the Company at the date of adoption of these Articles is £41,514,400, divided into.
    - (i) 5,991,886 A ordinary shares of £1 each,
    - (ii) 35,522,513 B ordinary shares of £1 each, and
    - (111) 1 C ordinary share of £1
  - 3A2 Except as provided in these Articles, the A ordinary shares, the B ordinary shares and the C ordinary shares shall rank pari passu in all respects but shall constitute separate classes of shares
  - 3A3 In any financial year, the profits available for distribution (within the meaning of Part 23 of the Companies Act 2006) of the Company (Available Profits) shall be used to pay dividends as set out as follows
    - (a) the A ordinary shares of £1 each shall be solely entitled to all Available Profits attributable to the Company's interests in Viglen Technology Limited (company number 04495621), Amscreen Pic (company number 06618670) and Amsair Limited (company number 02826152),
    - (b) the B ordinary shares of £1 each shall be solely entitled to all Available Profits save for such Available Profits to which the A ordinary shares and the C ordinary shares are entitled; and
    - (c) the C ordinary share of £1 shall be entitled solely to all Available Profits attributable to the Company's interests in Amstar Media Limited (company number 06039349)
  - On a return of assets on liquidation, capital reduction or otherwise, the assets of the Company remaining after the payment of its liabilities shall (to the extent that the Company is lawfully able to do so) be applied as follows
    - (a) the A ordinary shares of £1 each shall be solely entitled to all capital attributable to the Company's interests in Viglen Technology Limited, Amscreen Pic and Amsair Limited,
    - (b) the B ordinary shares of £1 each shall be solely entitled to all capitalsave for such capital to which the A ordinary shares and C ordinary shares are entitled, and
    - (c) the C ordinary share of £1 shall be entitled solely to all capital attributable to the Company's interests in Amstar Media Limited

4. The liability of any Member in default in respect of a call shall be increased by the addition at the end of the first sentence of Clause 18 in Table A of the words "and all expenses that may have been incurred by the Company by reason of such non-payment".

## GENERAL MEETINGS AND RESOLUTIONS

- 5. (a) A notice convening a General Meeting shall be required to specify the general nature of the business to be transacted only in the case of special business and Clause 38 in Table A shall be modified accordingly.
- All business shall be deemed special that is transacted at an Extraordinary General Meeting, and also all that is transacted at an Annual General Meeting, with the exception of declaring a dividend, the consideration of the accounts, balance sheets, and the reports of the Directors and Auditors, and the appointment of, and the fixing of the remuneration of, the Auditors.
- (b) Every notice convening a General Meeting shall comply with the provisions of Section 372(3) of the Act as to giving information to Members in regard to their right to appoint proxies; and notices of and other communications relating to any General Meeting which any Member is entitled to receive shall be sent to the Directors and to the Auditors for the time being of the Company.
- (a) Clause 40 in Table A shall be read and construed as if the words "at the time when the Meeting proceeds to business" were added at the end of the first sentence.
- (b) If a quorum is not present within half an hour from the time appointed for a General Meeting the General Meeting shall stand adjourned to the same day in the next week at the same time and place or to such other day and at such other time and place as the Directors may determine; and if at the adjourned General Meeting a quorum is not present within half an hour from the time appointed therefor such adjourned General Meeting shall be dissolved.
  - (c) Clause 41 in Table A shall not apply to the Company.

## APPOINTMENT OF DIRECTORS

- (a) Clause 64 in Table A shall not apply to the Company.
- (b) The maximum number and minimum number respectively of the Directors may be determined from time to time by Ordinary Resolution in General Meeting of the Company. Subject to and in default of any such determination there shall be no maximum number of Directors and the minimum number of Directors shall be one. Whensoever the minimum number of the Directors shall be one, a sole Director shall have authority to exercise all the po are and discretions by Table A and by these Articles expressed to be vested in the Directors ",enerally, and Clause 89 in Table A shall be modified accordingly

- (c) The Directors shall not be required to retire by rotation and Claures 73 to 86 (inclusive) in Table A shall not apply to the Company.
- (d) No person shall be appointed a Director at any General Meeting unless either-
  - (i) he is recommended by the Directors; or
- (ii) not less than fourteen nor more than thirty-live clear days before the date appointed for the General Meeting, notice executed by a Member quality to vote at the General Meeting has been given to the Company of the intention to propose that prison for appointment, together with notice executed by that person of his willingness to be appointed.
- (e) Subject to paragraph (d) above, the Company may by Ordinary Resolution in General Meating appoint any person who is willing to act to be a Okuctor, either to illi a vacancy or as an additional Director.
- (f) The Directors may appoint a person who is willing to act to be a Director, either to Ilii a varency or as an additional Director, provided that the appointment does not cause the number of Directors to exceed any number determined in accordance with paragraph (b) above as the maximum number of Directors and for the time being in force.

#### **BORROWING POWERS**

8. The Directors may exercise all the powers of the Company to borrow money without limit as to amount and upon such terms and in such manner as they think fit, and subject (in the case of any security convertible into shares) to Section 80 of the Act to grant any mortgage, charge or standard security over its undertaking, property and uncalled capital, or any part thereof, and to issue debontures, debenture stock, and other securities whether outright or as security for any debt, itability or obligation of the Company or of any third party.

#### ALTERNATE DIRECTORS

- 9. (a) An alternate Director shall not be entitled as such to receive any remuneration from the Company, save that he may be paid by the Company such part (if any) of the remuneration otherwise payable to his appointer as such appointer may by notice in writing to the Company from time to time direct, and the first sentence of Clause 68 in Table A shall be modified accordingly.
- (b) A Director, or any such other person as is mentioned in Clause 65 in Table A, may act as an alternate Director to represent more than one Director, and an alternate Director shall be entitled at any meeting of the Directors or of any committee of the Directors to one vote for every Director whom he represents in addition to his own vote (if any) as a Director, but he shall count as only one for the purpose of determining whether a quorum is present.

### DISQUALIFICATION OF DIRECTORS

16. The office of a Director shall be vacated if he becomes incapable by reason of illness or injury of managing and administering his property and affairs, and Clause 81 in Table A shall be modified accordingly.

## GRATUITIES AND PENSIONS

- 11. (a) The Directors may exercise the powers of the Company conferred by Clausa 3(.) of the Memorandum of Association of the Company and shall be entitled to retain any benefits received by them or any of them by reason of the exercise of any such powers.
  - (b) Clause 87 in Table A shall not apply to the Company.

## PROCEEDINGS OF DIRECTORS

- 12. (a) A Director may vote, at any meeting of the Directors or of any committee of the Directors, on any resolution, notwithstanding that it in any way concerns or relates to a matter in which he has, directly or indirectly, any kind of interest whatsoever, and if he shall vote on any such resolution as aforesald his vote shall be counted; and in relation to any such resolution as aforesald he shall (whether or not he shall vote on the same) be taken into account in calculating the quorum present at the meeting.
  - (b) Clauses 94 to 97 (inclusive) in Table A shall not apply to the Company.

## INDEMNITY

- 13. (a) Every Director or other officer of the Company shall be indemnified out of the assets of the Company against all losses or liabilities which he may sustain or incur in or about the execution of the duties of his office or otherwise in relation thereto, including any liability incurred by him in defending any proceedings, whether civil or criminal, in which judgment is given in his favour or in which he is acquitted or in connection with any application under Section 144 or Section 727 of the Act in which relief is granted to him by the Court, and no Director or other officer shall be liable for any loss, damage or misfortune which may happen to or be incurred by the Company in the execution of the duties of his office or in relation thereto. But this Article shall only have effect in so 4.5 as its provisions are not avoided by Section 310 of the Act.
  - (b) Clause 118 in Table A shall not apply to the Company.

## TRANSFER OF SHARES

14. The Directors may in their absolute discretion and without assigning any reason therefore, decline to register the transfer of a share, whether or not it is a fully paid share, and the first sentence of Clause 24 in Table A shall not apply to the Company.
