For the year ended 31 December 2019 the Company was entitled to exemption from audit under section 480 of the Act, relating to dormant companies.

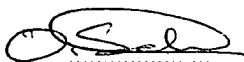
The sole member has not required the Company to obtain an audit in accordance with section 476 of the Act.
