In addition we enclose a copy of resolutions passed at an Extraordinary General Meeting of the company on 20 August 1998. The meeting was held to regularise certain matters relating to the share capital of the company which came to light following our acquisition of this company on 4 June 1998. In short following a reclassification of authorised but unissued ordinary shares as "A" ordinary shares there resulted a shortfall of 36,000 ordinary shares upon the exercise of options.

You will note that we have included a separate schedule showing past and present members. There remain certain issues and clarifications relating to earlier filings to be resolved with the two London law firms who were involved in the acquisition negotiations and who represented the parties to the transaction,

The foregoing investigation, which is ongoing, by the Secretarial Department is attributable to the delay in filing the accompanying Return and resolutions and we would suggest that, pending the conclusion of our investigations, a copy of this letter is filed with the Annual Return.
