DIRECTORS' REPORT

The Directors present their report and the unaudited financial statements for the year ended 31 March 2017

Principal Activities and Business Review:

The Company purchased the freehold of 19 Macaulay Road on the 18th December 1989 and the principal activity of the company during the year under review continued to be the ownership of 19 Macaulay Road and the management, administration and maintenance, on a non-profit making basis, of the common parts of the property at 19 Macaulay Road and 5 flats occupied by the lessees

Review of Finances:

The company being non-trading has no revenue. All expenditure is therefore charged pro-rata to the lessees.

Lessees make quarterly Standing Order payments into the company's bank account, of an amount agreed in advance – further exceptional accounts will be presented for payment if required to cover agreed expenditure that exceeds the amounts provided for by these Standing Order payments. In a situation in which the Income exceeds the expenditure within one financial year the balance will be carried forward as part of a "reserve fund". During the year covered by these accounts the annual charge was £1000.00 for the five tenants.
