

- 1 5 agreed that upon or following the occurrence of an Event of Default which is continuing unremedied and unwaived, if the Agent so requests in writing, procure that the Security Trustee's ownership of the Units hereby assigned is immediately entered in the Register
- 1 6 For the avoidance of doubt, it was confirmed in the Deed that, for the purposes of Article 3 of the Law, the Security Trustee is the secured party (for itself and on behalf of each Finance Party) and the Company is the debtor

#### 2 Guarantee

- 2 1 Subject to Clause 2 2 of the Guarantee, the Company irrevocably and unconditionally guaranteed the payment or discharge to the Security Trustee of (and undertook that the Company will on demand pay or discharge to the Security Trustee) all monies which are from time to time due by the Obligors to the Finance Parties under the Finance Documents, whether incurred actually or contingently and alone or jointly with ant other person, including all interest, costs, charges and other expenses payable by the Obligors under the Finance Documents
- 2 2 The Security Trustee's recourse under the Guarantee and the Deed is limited to the aggregate proceeds of the Collateral actually received by the Security Trustee as a result of the exercise by the Security Trustee of a power of sale over the Collateral pursuant to the Deed and the liability of the Company under the Guarantee and the Deed is limited to such proceeds

#### 3 Further Assurance

- 3 1 The Company agreed that from time to time forthwith upon the written request of the Security Trustee the Company shall promptly sign, execute and deliver to the Security Trustee all further instruments and documents which the Security Trustee may require for the purpose of obtaining the full benefit or intended benefit of the Deed
- 3 2 For the purpose of facilitating the exercise of the powers of the Security Trustee under the Law and pursuant to the Deed, the Company irrevocably appointed the Security Trustee as its attorney (with full power of substitution) to sign, execute, seal, deliver acknowledge, file, register and perfect any and all assurances, documents, instruments, agreements, transfers, certificates and consents whatsoever and to do any and all such acts and things whatsoever which the Company has capacity to do in relation to any matters dealt with in or the subject of the Deed and which the Security Trustee may deem necessary or advisable in order to give full effect to the purpose of the Deed, including, without limitation any of the matter referred to in Clause 9 (Enforcement by the Security Trustee) of the Deed
