UPON THE APPLICATION of the Applicant issued on 23rd September 2011,

AND UPON HEARING Counsel on behalf of the Applicant,

AND UPON the Respondents having been given notice of the hearing, none of the Respondents attending,

AND UPON READING the documents on the Court file,

IT IS ORDERED THAT -

In respect of those Bankruptcies, Individual Voluntary Arrangements ("IVAs")
Administrations, Company Voluntary Arrangements ("CVAs"), Compulsory
Liquidations and Creditors Voluntary Liquidations ("CVLs") listed in the attached
Schedule ("Schedule 1") which are the subject of proceedings in the County
Courts, other District Registries and Royal Courts of Justice, those proceedings
be transferred to the High Court, Leeds District Registry, solely for the purposes
of hearing the application for the Orders contained in paragraphs 2 to 10 below

- The Applicant be removed from office of those estates of individuals for which he is the sole appointee, including Supervisor of IVAs and Trustee in Bankruptcy (as the case may be) listed in Schedule 1 which will all be transferred to the First Respondent alone with immediate effect pursuant to rule 7 10B(2) of the Insolvency Rules 1986
- 3 The Applicant be removed from office of the estates of the companies, including Supervisor of CVAs. Administrator and Liquidator (both Compulsory and Voluntary) for which he is the sole appointee or joint appointee with the Second and Third Respondents listed in Schedule 1 which will all be transferred to the First Respondent and where appropriate the First Respondent together with the Second or Third Respondents as indicated in Schedule 1 with immediate effect
- The Applicant be replaced as such office holder in the case of each such estate by the First Respondent named in Schedule 1 as his proposed replacement, these replacements to take effect within the timescales referred to at paragraphs 2 and 3 above
- 5 The Applicant shall be entitled to -
  - 5.1 publish in the Gazette one composite notice relating to all new appointments which are required by law to be published in the Gazette,
  - apportion the costs of the said composite Gazette notice between those estates with sufficient funds to discharge the costs of this application in full equally, and
  - 5.3 charge to each individual estate the costs of obtaining an Insolvency Practitioner's licence bond in respect of that estate
- The Applicant shall be granted his release as appropriate 21 days after the publication in the Gazette referred to above
- Without incurring any additional expenses to any of the said estates, the First Respondent shall, when the next routine report is due to the creditors of each

estate, notify each creditor of the making of this Order, such notice to contain the following matters -

- 7.1 An explanation of the effect of the Order
- 7.2 Express reference to the liberty to apply contained in paragraph 8 below
- 7 3 In the case of IVAs and CVAs, the provision of all such information as might reasonably be required with regard to the conduct of the IVA or CVA (as the case may be)
- In the case of the Creditors' Voluntary Liquidations and Bankruptcies under the Insolvency Act 1986 where liquidation and creditors' committees have been appointed, an explanation that (to the extent that any information which would otherwise be required to be provided under Insolvency Rule 4 108(3) or Rule 6 126(2) has not already been provided as part of the routine report) it is open to that committee to require the First Respondent appointed to provide an account of the administration of the estate, including -
- 7.4.1 a summary of receipts and payments, and
- 7 4 2 a statement that he has reconciled his accounts
- In the case of CVLs and Bankruptcies under the Insolvency Act 1986 where no liquidation or creditors' committees have been appointed, an explanation that (to the extent that such information has not already been provided as part of the routine report) it is open to that creditor to apply to the Court for an Order that the First Respondent appointed do provide such information as might otherwise be required by Rule 4 108(3) or Rule 6 126(2) (as the case may be) That is to say, an account of the administration of the estate, including -
- 751 a summary of receipts and payments, and
- 7 5 2 a statement that he has reconciled his accounts

- notification that the First Respondent has been required to provide information referred to in paragraphs 7.5.1 and 7.5.2 above, whether by liquidation, creditors' committee or by Court Order on the application of any individual creditors, the First Respondent's costs of so complying will, unless there are good reasons to the contrary, be paid as an expense of the bankruptcy or liquidation as the case may be
- 7 7 in the case of liquidations under the Insolvency Act 1986, notification to each creditor and member of his/her right under Rule 11(2)(voluntary winding up) of the Insolvency Regulations 1994 to require the appointed First Respondent to supply a statement of receipts and payments free of charge
- In the case of bankruptcies under the Insolvency Act 1986, notification to each creditor of his/her right under Rule 25 of the Insolvency Regulations 1994 to require the appointed First Respondent to supply a statement of receipts free of charge
- 8 Liberty to each creditor of each estate to apply to vary or discharge this Order within 21 days of receipt of the notices directed to be sent under paragraph 7 above
- An Order that following the Orders made in paragraphs 1 to 8 above, the bankruptcies, IVAs, CVAs, Administrations, Compulsory Liquidations and CVLs, referred to in Schedule 1 be transferred back to the respective County Courts, District Registries and Royal Courts of Justice, as the case may be
- The costs of this application (including VAT) be aggregated and apportioned equally between each of the estates listed in Schedule 1 provided that,-
  - 10.1 If the costs which fall to be borne by any of the estates exceeds 10% of the realisable assets within that estate,
  - that estate shall only bear part of those apportioned costs, that part being an amount equal to 10% of that estates readily realisable assets,

- the excess shall be apportioned and borne rateably amongst the other estates in proportion of their realisable assets
- The Applicant do transfer the bank accounts and do all that is necessary to facilitate the efficient transfer of the said estates to the First Respondent upon receipt of Order
