Appointment of Auditors:

It was reported that following the merger in the UK of Coopers & Lybrand and Price Waterhouse, which was completed on 1 July 1998, Coopers & Lybrand had, in accordance with the requirements of the Partnership Acts and the Companies Acts, given notice of their intention to resign as London Electricity plc's auditors. This formal notice, in accrodance with Section 394 of the Companies Act 1985, would be lodged at Companies House.

The new partnership, PricewaterhouseCoopers, confirmed it would take over the audit appointments of the London Electricity plc Group on the same terms and conditions as before for Coopers & Lybrand.

IT WAS RESOLVED THAT notice of the resignation of Coopers & Lybrand as auditors of the Company having been received:
