# Directors' report

The directors present their annual report and the audited financial statements for the year ended 31 December 2000.

### Principal activities

The principal activity of the company is the ownership of the railway line from Meldon Quarry to its junction with the Exeter to Barnstaple line.

During 1999 the operation of the railway line was assumed by Dartmoor Railway Limited.

### Results and dividends

The company made a loss on ordinary activities in the year of £4,000 (1999: Loss £25,000). The directors do not recommend the payment of a dividend. The loss of £4,000 has been deducted from reserves.
