The Directors present their annual report and financial statements for the year ended 31 March 2002.

PRINCIPAL ACTIVITIES

The company is a non-trading holding company of Shanks Chemical Services (Scotland) Limited (SCSL). SCSL is engaged in the business of the recovery of industrial solvents and chemicals and the manufacture of chemicals.

TRADING RESULTS AND DIVIDENDS

The Company is a non-trading holding company. Details of its Subsidiary Company are set out at Note 3 to the financial statements. The Directors recommend that no dividend be paid in respect of the year ended 31 March 2002 (2001: £Nil).

DIRECTORS AND DIRECTORS' INTERESTS

The composition of the Board during the year was as follows:

None of the Directors had a direct interest in the share capital of the Company. Messrs Averill and Downes are also Directors of Shanks Group plc and accordingly their interests in the share capital of that company are disclosed in its accounts. Mr Brown is a Director of Shanks & McEwan (Environmental Services) Limited and his interests in the share capital of Shanks Group plc are disclosed in its accounts. The Directors had no interests in the shares of any other Company in the group.

STATEMENT OF DIRECTORS' RESPONSIBILITIES

They are also responsible for safeguarding the assets of the Company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

5 SHARE CAPITAL - continued

The Redeemable Preference shares carry a fixed cumulative preferential dividend at the rate of 10% per annum, payable half yearly in arrears on 31 March and 30 September. The shares have a redemption entitlement of £1.90. On winding up, the holders have priority before all other classes of shares to receive payment of capital plus any arrears of dividend and the redemption premium. The holders have one vote per share.

Ordinary 'A' shares have the same rights as Ordinary shares except on voting. On a poll, ordinary shares have 2 votes per share and 'A' shares have 1 vote. On a show of hands they each have one vote per share.
