

1. ACCOUNTING POLICIES

4. ULTIMATE PARENT UNDERTAKING

As at 31 December 2018, the Company's ultimate parent undertaking and the parent that headed the largest group of undertakings for which consolidated financial statements were prepared was London Stock Exchange Group plc. The Company's parent is London Stock Exchange plc. Both companies are incorporated in England and Wales. The whole of the issued share capital of the Company was beneficially owned by its parent undertaking London Stock Exchange plc.

The results of The London Stock Exchange Retirement Plan Trustee Company Limited formed part of the consolidated accounts of the ultimate parent undertaking for the year ended 31 December 2018. A copy of those accounts can be obtained from the London Stock Exchange, 10 Paternoster Square, London EC4M 7LS.

In May 2006, London Stock Exchange Group plc became the ultimate parent undertaking of the Company, following a scheme of arrangement under which it became the holding company of London Stock Exchange plc.
