

Each of the Respondents shall be released from all liability pursuant to the relevant sections of the Insolvency Act 1986 in respect of their acts and omissions and otherwise in respect of their conduct as administrator, liquidator (voluntary or compulsory), or supervisor (as the case may be) of the companies listed as being in administration, creditors' voluntary liquidation, compulsory liquidation or company voluntary arrangement (page 1 of Schedule 2), in the case of each Respondent such release to take effect in relation to each relevant estate 28 days after the date of the report or routine report referred to in paragraph 6 2 of this Order.
- 5. The Applicants shall be entitled to.
- 5.1 Publish in the London Gazette composite notices relating to all of the resignations and appointments as detailed in Schedule 2 and must do so within 14 days of the coming into effect of parts 2 and 3 of this Order;
- 6. Without incurring any additional expense to any of the said estates, the Applicants shall.
- 6 1 Notify the Secretary of State as soon as reasonably practicable of the making of this Order: and

6 2 Notify the creditors of the making of this Order and provide an explanation of the effect of the Order, when the next report or routine report is due to creditors of each estate, or earlier if appropriate.
