Meeting Details - See Action points

We are now into the ninth month of our appointment and the Company were anxious to ascertain as far as possible total registration expenditure per annum for their budgetary/year end purposes. This was also the first visit to LBR of the founder and Chief Executive of the Company - David Thomas, who in his own words "wanted to see what he was spending his money on". Barry Vintner, the Company's independent Company Secretary (i.e. he is also the Company's Solicitor) had already visited us soon after the Flotation last year and is our main contact for all registration matters.

Barry had presented me with a multi-point agenda (30 items!) the day before the meeting and a very full day was therefore on the cards.

Duncan Beveridge, the Company's Financial Controller was also at the meeting, although almost all the talking was done by David Thomas with both the others deferring to him!

This Company will generate in excess of £75K fees per annum and it was therefore felt most important that the Company is fully aware of all our services and general working procedures.

In addition to the basic service they already take our Sharewatch service and a Remote Link. We also look after two small Executive S.O.S's for them. Their Sharesave Scheme is currently with the Yorkshire B.S. - we did in fact present to then but £ for £ David Thomas thought they were better value!! (refer Mike James).

We did in fact manage to get through all the points on the agenda together with some of ours! The result was a very successful day, both in terms of awareness from the Company's viewpoint of how we work in detail and a strengthening of the initial rapport gained at our first meeting last year. Indeed I have learnt since the meeting from Barry Vintner that the CEO was impressed with all he had seen and heard and was reassured that he had made the right choice of registrar.


