"Christian name" includes n forename, in the case of a peer or person usually known by a title different from his surname, "surnamo" moans that title, in the case of a corporation, its corporate name must be given,

A previous christian name or surname need not be given it;-

- (a) In the case of a married woman, it was a name by which she was known before her marriage; or
- (b) it was changed or ceased to be used at least 20 years ago, or before the person who previously used it reached the age of 18; or
- (c) in the case of a peer or a person usually known by a British title different from his surname, it was a name by which he was known before he adopted the title or succeeded to it

- Usual residential address must be given, in the case of a corporation, give the registered or principal office.
- Date of birth need only be given if the company making the return la:--
  - (a) a public company; (b) the subsidiary of a public company; or (c) the subsidiary of a public company registered in Northern Ireland

- (d) a wholly-owned subsidiary of a body corporate of which the company making the return was ulso a wholly owned subsidiary.
