

Report of the Directors For the Year Ended 31 December 2015

The directors present their report with the financial statements of the company for the year ended 31 December 2015.

PRINCIPAL ACTIVITY

The principal activity of the company in the year under review was that of general partner of the Enterprise Venture Fund, a limited partnership registered under the Limited Partnership Act 1907.

The company qualifies as small in accordance with the provisions of s382(3) of the Companies Act 2006 and is therefore exempt from the requirement to present an enhanced business review and exemption from preparing a Strategic Report.

REVIEW OF BUSINESS AND FUTURE DEVELOPMENTS

The results for the year and financial position of the company are as shown in the annexed financial statements. Income from the limited partnership to this company ceased in March 2010 in line with the partnership agreement; however the life of the Fund has been extended until the last of the partnership's investments is realised or disposed of and the general partner is now incentivised by a performance fee based on the realisation of the last investments. The directors do not expect a significant change in the activities of the business in the future and look forward to the future with confidence.

In considering the appropriateness of the going concern basis, the directors have reviewed the company's on-going financial commitments for the next 12 months and beyond, including the company's working capital requirements. As a result the directors have satisfied themselves that it is appropriate to prepare these financial statements on a going concern basis.

The company is a wholly owned subsidiary of Enterprise Ventures Limited, which is a wholly owned subsidiary of Enterprise Ventures Group Limited by Mercia Technologies PLC on 9 March 2016

DIVIDENDS

No dividends will be distributed for the year ended 31 December 2015 (2014: £Nil).

The directors are responsible for keeping adequate accounting records that are sufficient to show and explain the company's transactions and disclose with reasonable accuracy at any time the financial position of the company and enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities. Legislation in the United Kingdom governing the preparation and dissemination of financial statements may differ from legislation in other jurisdictions.

Report of the Independent Auditors to the Members of Enterprise Ventures (General Partner EVF/LEV) Limited

We have audited the financial statements of Enterprise Ventures (General Partner EVF/LEV) Limited for the year ended 31 December 2015, which comprise the Profit and Loss Account, the Balance Sheet and the related notes 1 to 9. The financial reporting framework that has been applied in their preparation is applicable law and the Financial Reporting Standard for Smaller Entities (Effective April 2008) (United Kingdom Generally Accepted Accounting Practice applicable to Smaller Entities).

1. ACCOUNTING POLICIES

The financial statements have been prepared in accordance with applicable law and accounting standards in the United Kingdom. A summary of the principal accounting policies applied consistently in both the current and prior year is set out below. The company qualifies as small in accordance with the provisions of s382(3) of the Companies Act 2006.

Accounting convention

The financial statements have been prepared under the historical cost convention.

In considering the appropriateness of the going concern basis, the directors have reviewed the company's on-going financial commitments for the next 12 months and beyond, including the company's working capital requirements. As a result the directors have satisfied themselves that it is appropriate to prepare these financial statements on a going concern basis.

Turnover

Turnover represents income due from the Enterprise Venture Fund, as a first charge on the net income and capital gains of the fund.

Cash flow statement

The exemption available in FRS1 (Revised 1996) 'Cash Flow Statements' has been taken from preparing a cash flow statement on the grounds that the company is wholly owned within a group and consolidated accounts, which include this company's results, are publicly available.

2. STAFF COSTS

The directors did not receive any emoluments from the company during the current or previous statements.

The company had no employees other than the directors in the current or previous year.

3. AUDIT FEES

The audit fee of £800 (2014: £800) is paid by the parent company and is not recharged.

4. TAXATION

No liability to UK corporation tax arose on ordinary activities for the year ended 31 December 2015, nor for the year ended 31 December 2014.

7. ULTIMATE PARENT COMPANY AND CONTROLLING PARTY

The company is a wholly owned subsidiary of Enterprise Ventures Limited, a company registered in England and Wales. The parent company of the largest and smallest groups of which Enterprise Ventures (General Partner EVF/LEV) Limited is a member and for which group accounts are drawn up is Enterprise Ventures Group Limited, whose principal place of business is Preston Technology Management Centre, Marsh Lane, Preston, PR1 8UQ. Enterprise Ventures Group Limited is a wholly owned subsidiary of Mercia Technologies PLC as of 9 March 2016. As Enterprise Ventures (General Partner EVF/LEV) Limited was a wholly owned subsidiary of Enterprise Ventures Limited as at the year end date 31 December 2015, the company's accounts have been consolidated within the Enterprise Ventures Group Limited and are available to the public and may be obtained from the above address.

8. RELATED PARTY TRANSACTIONS

The company has taken advantage of the exemption in FRS8 "Related Party Transactions" and has not disclosed transactions with group undertakings.

The income of the company is derived from the Enterprise Venture Fund, a fund managed by Enterprise Ventures Limited.
