#### **DIRECTORS' REPORT**

The directors submit their annual report and the audited financial statements for the year ended 31 December 2009. This report has been prepared in accordance with the special provisions relating to small companies within Part 15 of the Companies Act 2006.

### **CHANGE OF CONTROL**

On 12 January 2009 Commerzbank AG ('Commerzbank') completed the acquisition of the Company's intermediate parent undertaking, Dresdner Bank ('DBAG') The full legal merger of DBAG and Commerzbank took place on 11 May 2009 Following the merger, DBAG ceased to exist and all of the assets and liabilities of DBAG were succeeded by the new Commerzbank

## PRINCIPAL ACTIVITY AND REVIEW OF THE BUSINESS

The Company ceased the undertaking of leasing services in 2006. The Company remains the legal owner and lessor of assets on lease to a third party, for the benefit of Commerzbank London Branch.

Up until the payment of an interim dividend on 14 September 2009, the Company earned interest on deposits held with Commerzbank London Branch Since that date the Company's only transactions relate to collecting lease rentals for Commerzbank London Branch The directors do not expect the Company to enter into any new transactions in the foreseeable future

### **NAME CHANGE**

On 19 April 2010, the Company changed its name from Dresdner Kleinwort Leasing December (8) Limited to Commerzbank Leasing December (8) Limited

### RESULTS AND DIVIDENDS

The profit on ordinary activities after taxation was £11,299 (2008: £38,947) During the year an interim dividend of £711,599 (2008 £nil) was paid

## NOTES TO THE FINANCIAL STATEMENTS For the year ended 31 December 2009

### 1. ACCOUNTING POLICIES

#### **Basis** of preparation

The financial statements have been prepared in accordance with accounting standards applicable in the United Kingdom and under the historical cost convention

Following the payment of a dividend on 14 September 2009 the Company's only transactions relate to collecting lease rentals for Commerzbank London Branch Accordingly the directors continue to prepare the financial statements on the going concern basis.

### Interest receivable

Deposit interest receivable is accounted for on an accruals basis

#### **Taxation**

The charge for taxation is based on the results for the year

#### Related party transactions

The Company's ultimate parent undertaking, Commerzbank, prepares consolidated financial statements, which are publicly available. Accordingly advantage is taken in these financial statements of the exemptions available in FRS 8, 'Related Party Disclosures' for disclosure of transactions with entities that are part of the group or investees of group entities as related parties.

### Cash flow statement

The Company has taken advantage of the exemption under FRS 1 (revised) 'Cash Flow Statements' not to prepare a cash flow statement on the grounds that the ultimate parent undertaking, Commerzbank, prepares consolidated financial statements, which are publicly available

#### 2. ADMINISTRATIVE EXPENSES

All administrative expenses, including auditors' remuneration for services to the Company, were borne by a fellow subsidiary undertaking. The Company had no employees during the year. None of the directors received any emoluments in respect of their services to the Company. The audit fee applicable in respect of this Company's financial statements was £3,000 (2008 £4,200), with no further services provided to the Company by the Company's auditor.
