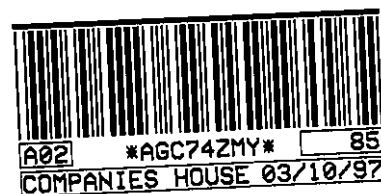

The interests of J J Cockburn and C R Chapman in the share capital of Nestor Healthcare Group plc are disclosed in the accounts of that company.


Registered office
