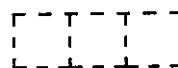

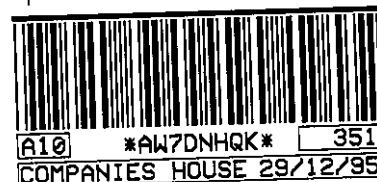



1.
