"Christian name" includes a forename. In the case of r peer or person usually known by a title different from his surname, "surnome" meens that title. In the care of a corporation, its corporate name must be given.

A previous christian name or surname need not be given if:-

- (a) in the case of a married woman, it was a name by which she was known before her marriage; or
- (b) it was changed or ceesed to be used at least 20 years ago, or . before the person who previously used it reached the age of 18; or
- (c) in the case of a peer or a person usually known by a Eritish title different from his sumame, it was a name by which he was known before he adopted the title or succeeded to it

- Date of birth need only be given if the company making the return is:-
 - (a) a public company; (b) the subsidiary of a public company; or (c) the subsidiary of a public
 - company registered in Northern Ireland
- The names must be given of all bodies corporate incorporated in Great Britain of which the director is also a director, or has been a director at any time during the preceding five years.
