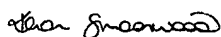
- select suitable accounting policies and then apply them consistently;

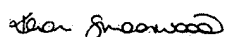
There have been no changes to the Company's equity during either of the years under review and so no separate statement of changes in equity is presented.

Notes to the financial statements for the year ended 31 March 2023

1. Corporate information

The Company is a private company limited by shares, incorporated and domiciled in England and Wales. Its registered office is at The Sir John Peace Building, Experian Way, NG2 Business Park, Nottingham, NG80 1ZZ and its registered number is 02518523. The Company is dormant.

2. Basis of preparation

These financial statements have been prepared on a basis other than going concern, under the historical cost convention in accordance with FRS 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' ('FRS 102') and the requirements of the Companies Act 2006.

Estimates and judgments

The use of critical accounting estimates and management judgment is required in applying the accounting policies. Areas involving a higher degree of judgment or complexity, or where assumptions and estimates are significant to the Company financial statements, are disclosed in note 4.

3. Significant accounting policies

The principal accounting policies applied in the preparation of these financial statements are set out below and have been consistently applied to both years presented, unless otherwise stated.

Reporting currency

These financial statements are presented in US dollars, the Company's functional currency.

4. Critical accounting estimates, judgments and assumptions

(i) Critical accounting estimates and assumptions

There are no estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

(ii) Critical judgments

There are no critical judgments in the case of these financial statements.

5. Profit and loss account and statement of comprehensive income

The Company did not trade during the current or prior year and accordingly no profit and loss account is presented. It had no other income or charges in either the current or prior year and accordingly no statement of comprehensive income is presented.

No directors received any remuneration in respect of their services to the Company, either from the Company or from other group undertakings, during the year ended 31 March 2023 (2022: US\$nil).

The Company had no employees during the current or prior year and accordingly no employee costs are included in these financial statements (2022: US\$nil).

6. Cash flow statement
