

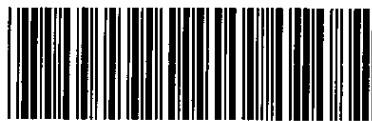

- (5) The Claimant do pay to the Registrar of Companies her costs of the said Application in the agreed sum of £300.00.
