

THIS DEED OF ASSIGNMENT is made on 4 September 2014

BETWEEN:

- (1) **BA CITYFLYER LIMITED**, a limited liability company incorporated and existing under applicable law of England and Wales (company no 02571224) having its registered office at Waterside PO Box 365, Harmondsworth, West Drayton, Middlesex, UB7 0GB, England (Assignor), and
- (2) BRITISH AIRWAYS E-JETS LEASING LIMITED, a limited liability exempted company incorporated under the laws of Bermuda with registered company number 42992 having its registered office at Canon's Court, 22 Victoria Street, Hamilton HM12, Bermuda (Assignee, which expression shall include its successors and assigns)

WHEREAS:

- (A) The Assignee is leasing the Aircraft to the Assignor pursuant to the Lease Agreement
- (B) In compliance with its obligations pursuant to the Lease Agreement, the Assignor has obtained and is maintaining the Insurances relating to the Aircraft
- (C) The Assignor has agreed to assign its interest in the Insurances relating to the Aircraft (other than third party insurances) to the Assignee in order to secure the obligations of the Assignor under the Lease Agreement and the payment of all amounts due thereunder

THIS DEED OF ASSIGNMENT WITNESSES as follows

1 Definitions and Interpretation

11 Definitions

Unless otherwise defined herein, in this Deed of Assignment, capitalised words and expressions shall have the respective meanings given to them in Part 1 (Definitions) of Appendix A - Master Definitions Schedule

Aircraft means that certain Embraer ERJ 190-100 SR aircraft bearing manufacturer's serial number 19000674 together with any one or both of the two (2) GE model CF34E-10E aircraft engines bearing the manufacturer's serial numbers 424671 and 424672 respectively, as more particularly described in the Lease Supplement

Appendix A - Master Definitions Schedule means the master definitions schedule appended to the Security Trust Deed

Security Trust Deed means the security trust deed dated 1 September 2014, between the Assignee, Banco Nacional De Desenvolvimento Econômico e Social - BNDES and The Law Debenture Trust Corporation p I c

Unless expressly provided to the contrary in any Operative Document, no person who is not a Party to this Deed of Assignment shall be entitled to enforce any term of this Deed of Assignment pursuant to the Third Parties Act

2 Assignment

- As continuing security for the payment, performance and discharge to the Lessor of the Lessee Secured Obligations, the Other Lessee Secured Obligations and the 2012 Lessee Secured Obligations, the Assignor hereby, with full title guarantee, assigns and agrees to assign absolutely to the Assignee all of its present and future rights, title and interest in and to (1) the Relevant Insurances, (2) all the benefits of such policies and contracts in respect of such Relevant Insurances (including all claims of whatsoever nature thereunder and returns of premiums in respect thereof) and (3) all Requisition Compensation relating to the Aircraft For the avoidance of doubt, this Deed of Assignment does not constitute an assignment of any policy of insurance but only of the benefit, rights, title, interest and proceeds thereunder insofar as the same relates to the Aircraft
- The Assignee shall, at the cost and expense of the Assignor, re-assign the property assigned pursuant to clause 2.1 upon the Security Trustee becoming obliged to release the Mortgage in respect of the Aircraft pursuant to clause 5.1 (Release of Mortgage) of the Security Trust Deed or the Collateral (in so far as it relates to the Aircraft) pursuant to clause 4 (Disposals by the Security Trustee) of the Security Trust Deed and issue such notices of reassignment in respect of the property assigned pursuant to clause 2.1 as may reasonably be requested by the Assignor for the purpose of perfecting such reassignment
- Notwithstanding the provisions of clause 2.1, any and all Requisition Compensation which the Lessee is entitled to receive pursuant to clauses 21.3.1 and 21.3.2 of the Lease Agreement shall be paid to the Lessee until such time as an Enforcement Event shall occur and be continuing, whereupon the Assignor shall forthwith, and the Assignee may at any time thereafter whilst such Enforcement Event is continuing, instruct the person from whom such Requisition Compensation is then payable to pay such Requisition Compensation to the Assignee or as it may direct

3 Covenant

The Assignor covenants that it shall

- (a) promptly following execution of this Deed of Assignment give notice of this Deed of Assignment and the assignment herein contained to the insurance brokers through which the Relevant Insurances are from time to time effected and maintained in the form set out in schedule 5 to the Security Assignment and shall use its best endeavours to procure and deliver to the Assignee an acknowledgement of such insurance brokers in the form set out in schedule 5 to the Security Assignment, and
- (b) not further assign, pledge or charge its right, title and interest in and to the Relevant Insurances or the Requisition Compensation in respect of the Aircraft assigned by this Deed of Assignment or any proceeds thereof to anyone other than the Assignee

4 Further Assurance

The Assignor covenants that it will from time to time at the request of the Assignee do all such things and execute all such documents as the Assignee may reasonably consider necessary

or desirable for giving full effect to this Deed of Assignment or for securing the rights of the Assignee hereunder

5 Powers of the Assignee

The security created by this Deed of Assignment shall become immediately enforceable upon the giving by the Assignee of a notice declaring that an Enforcement Event has occurred and for as long as such Enforcement Event continues, whereupon the Assignee shall become entitled, as and when it may see fit and without further notice and without the restrictions contained in section 103 of the Law of Property Act 1925, to exercise in relation to the property assigned pursuant to clause 2.1 all or any of the rights, powers and remedies conferred upon mortgagees or chargees by any relevant law and/or conferred on the Assignee by virtue of this Deed of Assignment, and in particular (but without limiting the generality of the foregoing)

- (a) to require that all policies, contracts and other records relating to the Relevant Insurances (including details of and correspondence concerning outstanding claims) be delivered forthwith to such brokers as the Assignee may nominate, and
- (b) to bring, take, defend, compromise, submit to arbitration or discontinue any actions, suits or proceedings to collect, recover, compromise and give a good discharge for all claims then outstanding or thereafter arising under the Relevant Insurances or any of them and any Requisition Compensation and to take over or institute (if necessary using the name of the Assignor) all such proceedings in connection therewith as the Assignee, in its absolute discretion, thinks fit and to permit the brokers through whom collection or recovery is effected to charge the usual brokerage therefor

For the purposes of section 101 of the Law of Property Act 1925, the monies hereby secured shall be deemed to have become due and payable on the date of this Deed of Assignment

6 Power of Attorney

The Assignor hereby irrevocably by way of security and for so long as any Lessee Secured Obligations remain undischarged appoints the Assignee as its attorney (with full power of substitution and delegation) for and on its behalf and in its name and as its act and deed to execute, seal and otherwise perfect any document as is referred to in clause 4 (Further Assurance) and to do all such acts and execute all such documents necessary or desirable for the purpose of fully exercising its rights hereunder or effecting any release or discharge required by the insurers to permit the proceeds of Relevant Insurances to be dealt with in accordance with the terms of the Operative Documents in each case as it itself could have done or executed in relation to any Relevant Insurances taken out in respect of the Aircraft or in respect of any Requisition Compensation arising in respect of the Aircraft provided that the Assignee shall not exercise the authority conferred on it in this clause 6 unless an Enforcement Event has occurred and is continuing. The Assignor hereby ratifies and confirms and agrees to ratify and confirm, any deed, assurance, agreement, instrument, act or thing which the Assignee or any substitute or delegate may properly execute or do pursuant thereto.

7 Successors in title

The obligations on the part of the Assignor contained herein shall bind it and its successors and permitted assigns and shall inure to the benefit of the Assignee and its respective successors and assigns, whether so expressed or not

8 Continuing and Independent Security

- This Deed of Assignment and the security hereby created shall be a continuing security and, without limitation, shall not be, nor be considered as, satisfied by any intermediate discharge or payment of or on account of any liabilities or any settlement of accounts between the Assignor and the Assignee
- This Deed of Assignment and the security hereby created shall be in addition to and not in substitution for or derogation of any other security (whether given by the Assignor or otherwise) now or from time to time hereafter held by the Assignee in respect of or in connection with any or all of the Lessee Secured Obligations, the Other Lessee Secured Obligations and/or the 2012 Lessee Secured Obligations hereby secured
- The Assignee need not before exercising any of the rights, powers or remedies conferred upon it by this Deed of Assignment or by law (a) take action or obtain judgment against the Assignor or any other person in any court, (b) make or file claim or proof in a winding-up or liquidation of the Assignor or any other person or (c) enforce or seek to enforce the recovery of the Lessee Secured Obligations, the Other Lessee Secured Obligations and/or the 2012 Lessee Secured Obligations hereby secured or any other security such as is mentioned in clause 8.2
- The Assignee may in its discretion (a) grant time or other indulgence or make any other arrangement in respect of any of the Lessee Secured Obligations, the Other Lessee Secured Obligations and/or the 2012 Lessee Secured Obligations hereby secured or of any other security therefor or of any other person or persons not Parties hereto or (b) vary any provision of the Lease Agreement or any Operative Document without prejudice to this security and the security created by this Deed of Assignment shall not be in any way discharged or impaired by reason of any other circumstance which might (but for this provision) constitute a legal or equitable discharge of such security
- 8 5 Sections 93 (subject to clause 2 2) and 103 of the Law of Property Act 1925 shall not apply to this Deed of Assignment

9 Notices and Miscellaneous

- 9 1 The provisions of clause 29 (Notices) of the Lease Agreement shall apply mutatis mutandis to this Deed of Assignment
- This Deed of Assignment may be executed in any number of counterparts and all of such counterparts taken together shall be deemed to constitute one and the same instrument

10 Governing Law

This Deed of Assignment and all non-contractual obligations arising from, or connected with, it shall be governed by and construed in accordance with the laws of England

11 Jurisdiction

The courts of England have exclusive jurisdiction to settle any dispute arising out of, or in connection with, this Deed of Assignment (including a dispute relating to non-contractual obligations arising from, or in connection with, this Deed of Assignment, or a dispute regarding the existence, validity or termination of this Deed of Assignment or the consequences of its nullity) (Dispute)
