
For the year ended 31 December 2005 the company was entitled to exemption under section 249AA(1) of the Companies Act 1985.

The smallest such group is that headed by SITA Holdings UK Limited, a company registered in England & Wales. In the opinion of the directors, SITA Holdings UK Limited controls the company as a result of controlling 100% of the issued share capital of Openpitch Limited. Suez SA is the ultimate controlling party, being the ultimate controlling party of SITA Holdings UK Limited.
