#### 1. Assignments by way of security

in each case to the fullest extent capable of assignment and subject to reassignment on redemption as provided in clause 14 13 of the Mortgage

#### 2. First Fixed Charges

Charged in favour of the Lender the following assets:

any money (including any deposit, advance or instalment payment) payable to the Chargor for or in connection with the disposal (by whatever means and whether or not permitted by this deed) of the Mortgaged Chattels or any interest in the Mortgaged Chattels, and 2.2 any assets referred to in paragraph 1 above to the extent that such assets are incapable for any reason of being validly and effectively assigned to the Lender pursuant to that clause but are capable of being validly and effectively charged

#### 3 Floating Charge

Charged in favour of the Lender by way of first floating charge, all those assets described or referred to in paragraphs 1 or 2 above, but not validly or effectively assigned or charged by way of security pursuant to, the provisions of clauses 3.1.1 (Assignment by way of security) or 3.1 2 (First fixed charge) respectively of the Mortgage

#### 4. Additional Mortgaged Chattels

The Mortgage contains provisions whereby the Lender may by notice to the Chargor require any of the Mortgaged Chattels or any other chattel acquired by the Chargor after the date of the Mortgage to be added to Schedule 1 (Mortgaged Chattels) of the Mortgage and in such event a copy of Schedule 1 (Mortgaged Chattels) as so amended shall be signed by the Chargor and annexed to the Mortgage by way of endorsement, and from the date of such endorsement each such additional chattel shall stand charged by way of mortgage to the Lender by way of security or otherwise secured upon the terms of the Mortgage as if included in the definition of "Mortgaged Chattels"

#### 5. **General provisions**

- 5.1 All the security granted or created by the Mortgage is to be a continuing security which shall remain in full force and effect notwithstanding any intermediate payment or settlement of account or other matter or thing whatsoever and in particular the intermediate satisfaction by the Chargor or any other person of the whole or any part of the Secured Obligations.
- The fact that no or incomplete details of any particular Secured Assets are included or inserted in any relevant Schedule to the Mortgage shall not affect the validity or enforceability of the charges created by the Mortgage
- All the security created or given under the Mortgage is made with full title guarantee in accordance with the Law of Property (Miscellaneous Provisions) Act 1994.

#### 6. Restrictions on charges and disposals (Negative Pledge)

Clause 4 1 of the mortgage provides that, except as provided in clause 4.2 of the Mortgage, during the Security Period, the Chargor must not create, extend or permit to subsist any security over any of the Secured Assets, nor may it sell, transfer, lease or otherwise dispose of any of, or any interest in, the Mortgaged

Chattels, nor enter into any other preferential arrangement having a similar effect

- 6.2 The exceptions referred to at clause 4 2 of the Mortgage are
  - 6 2 1 the security created or required to be created by the Mortgage;
  - 6 2 2 the Permitted Security;
  - 6.3.3 any security, arrangement or transaction to which the Lender has given its written consent.

#### DEFINITIONS APPLICABLE TO THIS FORM

"Facility Agreement" means a credit facilities agreement dated and made between (1) the Chargor, (2) LPC (Properties) Limited, (3) LPC (UK) Limited, (4) Kamns Paper Mill Limited, (5) LPC Group plc and (6) the Lender for the provision of certain loan facilities.
