**UPON THE APPLICATION** of the Claimant by Part 8 Claim Form dated 10 January 2023 (the "Application")

**AND UPON READING** the CPR Part 8 Claim Form and the witness statement of Astrid Stanley dated 10 January 2023

AND UPON HEARING Philip Morrison, Counsel for the Claimant

AND UPON THE COURT considering the circumstances of the creation of (i) the charge with the charge code 026155240036 (the "2016 Charge") and (ii) the charge created by deed of legal charge created 28 September 2000 and delivered on 12 October 2000 (the "2000 Charge"), in each case appearing on the register maintained in respect of Mardan (Norwich) Limited (company number 02615524) (the "Charges")

**AND UPON** the Court being satisfied that two MR04 satisfaction of charge forms were submitted to the Registrar of Companies on 31 January 2022 which erroneously indicated that the 2000 Charge and 2016 Charge were satisfied in full (the "Erroneous MR04 Forms") when the correct position is that they were satisfied in part only

AND UPON the Court being satisfied that the statements of satisfaction appearing on the register (copies of which are appended as Schedule A to this Order) incorrectly record that the 2000 Charge and the 2016 Charge are fully satisfied (the "Erroneous Statements of Satisfaction") and as such are factually inaccurate in that they wrongly identify the Charges to which they relate as being fully rather than partially satisfied.

AND UPON the Court being satisfied, for the purposes of section 859M of the Companies Act 2006 (for the 2016 Charge) and section 404 of the Companies Act 1985 or section 873 of the Companies Act 2006 (as appropriate) (for the 2000 Charge), that the misstatements contained in the Erroneous MR04 Forms indicating that the Charges have been fully satisfied were accidental and/or due to inadvertence and/or due to some other sufficient cause and/or it are not of a nature to prejudice the position of the creditors or shareholders of the company and/or that on other grounds it is just and equitable to grant relief

**AND UPON** the Court being satisfied that the applicable legislative requirements are met and that it is appropriate to grant relief under those provisions

IT IS ORDERED THAT, pursuant to section 859M of the Companies Act 2006 or section 404 of the Companies Act 1985 or section 873 of the Companies Act 2006 (as appropriate):

- 1. The register be rectified to show the 2000 Charge as only satisfied in part (and not satisfied in full).
- The register be rectified to show the 2016 Charge as only satisfied in part (and not satisfied in full).
- 3. The Claimant will serve the sealed Order on Defendants.
- 4. There be no order as to Costs.
