## REPORT OF THE AUDITORS

### TO THE DIRECTORS OF SPITFIRE DIGITAL NETWORKS LIMITED

We have examined the abbreviated statutory accounts set out on pages 3 to 4, together with the full statutory accounts of the company. The scope of our work for the purpose of this report was limited to confirming the opinion set out in the following paragraph.

In our opinion, the Company is entitled under Sections 246 and 247 of the Companies Act 1985, to the exemptions conferred in section B of Part III of Schedule 8 to that Act in respect of the year ended 31st March 2000 and the abbreviated accounts have been properly prepared in accordance with that Schedule.

On 07th December 2000 we reported to the members on the full statutory accounts of the company prepared under Section 226 of the Companies Act 1985 for the year ended 31st March 2000. Our report under Section 235 of the Companies Act 1985 was as follows:

#### RESPECTIVE RESPONSIBILITIES OF DIRECTORS AND AUDITORS

#### BASIS OF OPINION

We conducted our audit in accordance with Auditing Standards issued by the Auditing Practices Board, except that the scope of our work was limited as explained below.

An audit includes examination, on a test basis, of evidence relevant to the amounts and disclosures in the financial statements. It also includes an assessment of the significant estimates and judgments made by the directors in the preparation of the financial statements, and of whether the accounting policies are appropriate to the company's circumstances, consistently applied and adequately disclosed.

We planned and performed our audit so as to obtain all the information and explanations which we considered necessary in order to provide us with sufficient evidence to give reasonable assurance that the financial statements are free from material misstatement, whether caused by fraud or other irregularity or error. In forming our opinion we also evaluated the overall adequacy of the presentation of information in the financial statements.





**1. ACCOUNTING POLICIES**

- **Basis of preparation of accounts**

The financial statements have been prepared under the historical cost convention.

- **Turnover**

Turnover represents the net amount of invoices to customers less credit notes for goods returned, excluding Value Added Tax.

- **Stock and Work in Progress**

Stock and Work in Progress is valued at the lower of Cost and Net Realisable Value after making due allowance for obsolete and slow-moving items.
