- The Applicant be removed from office as Joint Supervisor of the companies in an Company Voluntary Arrangement listed in Schedule 7 attached hereto with effect from the date of this order and the individuals named as Replacement Officeholders in Schedule 7 be appointed in substitution as Joint Supervisor in respect of the said Company Voluntary Arrangements with effect from the same date, pursuant to Section 7 of the Insolvency Act 1986.


