#### 3. CONTINGENCIES

The following contingencies exist in respect of £550,000 capital grants received from Foundation for Sport and the Arts in 1996.

Lottery Sports Fund

- 1) The grants are to be used solely towards financing Durham Indoor Bowling Community Association.
- 2) If the facility or part of the facility is sold, transferred or if the facility ceases trading within a period of
- 21 years an appropriate proportion of the proceeds will be surrendered to the Sports Council unless otherwise agreed by the Sports Council.
- 3) Also within the 21 year period any distributable profit made must be notified to the Sports Council and an appropriate proportion of this profit as determined by the Sports Council must be paid to them.

The company is entitled to exemption from audit under Section 477 of the Companies Act 2006 for the year ended 30 April 2018.

The members have not required the company to obtain an audit of its financial statements for the year ended 30 April 2018 in accordance with Section 476 of the Companies Act 2006.
