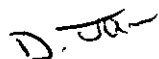
During the year ended 31 December 2000, the company did not trade or incur any liabilities and consequently made neither profit nor loss.

** This director received 1,051 additional shares on the exercise of share options held on 28 December 1995 as shown above. These shares compensated the director for the special dividend of 68.3p per share which was paid to former TSB Group shareholders following the merger with Lloyds Bank but which was not paid to option holders.
