**1. STATUTORY INFORMATION**

**Basis of preparing the financial statements**

**Service charge funds**

The service charge funds are held in trust on behalf of the leaseholders as required by Section 42 of the Landlord & Tenant Act 1987. All service charge transactions relating to the management of the property are reported separately and are excluded from the company's financial statements.
