#### **Notes to the Financial Statements**

## 1 Accounting policies

#### (a) Basis of preparation

The financial statements have been prepared under the historical cost convention and in accordance with applicable accounting standards. The accounts have been prepared as at 31 March 2012, being the last Saturday in March. The comparatives for the 2011 financial year are for the period ended 26 March 2011.

The Company has considerable net assets. As a consequence, after consideration of the credit risk of the loan made to its immediate parent company and the income this loan will provide, the Directors believe that the Company is well placed to manage its business risks successfully

The Directors have a reasonable expectation that the Company has adequate resources to continue in operational existence for the foreseeable future. Thus they continue to adopt the going concern basis of accounting in preparing the annual financial statements.

#### (b) Consolidation of subsidiaries

The financial statements contain information about De La Rue Scandinavia Limited as an individual company and do not contain consolidated financial information as the parent of a group of companies. The Company is exempt under section 400 of the Companies Act 2006 from the requirement to prepare consolidated financial statements as it and its subsidiary undertakings are included by full consolidation in the consolidated financial statements of its parent, De La Rue plc, a company registered in England and Wales. References to "Group" mean De La Rue plc and its subsidiaries.

#### (c) Foreign currencies

Transactions in foreign currencies are recorded using the rate of exchange ruling at the date of the transaction. Exchange gains or losses on monetary assets and liabilities are dealt with in the profit and loss account, except to the extent that they represent a hedge of the Company's overseas investments, which are dealt with in the reserves together with the exchange difference on the carrying value of the related investment.

#### (d) Taxation

The charge for taxation is based on the profit for the year and takes into account taxation deferred because of timing differences between the treatment of certain items for taxation and accounting purposes

Deferred tax is recognised, without discounting, in respect of all timing differences between the treatment of certain items for taxation and accounting purposes which have arisen but not reversed by the balance sheet date, except as otherwise required by FRS 19

#### (e) Investments

Investments are stated at cost or valuation in the balance sheet, less provision for any impairment in the value of the investment

## 2 Directors' emoluments & auditors' remuneration

The Directors and all other staff engaged on the Company's operations received no fees or other remuneration from the Company (2011 Nil) During the year under review Mr C C Child was employed by De La Rue plc, and with effect from 3 June 2011, Mr E H D Peppiatt was also employed by De La Rue plc (previously employed by De La Rue Holdings plc), and all were remunerated in respect of their services to the Group as a whole by their employing company Their emoluments are dealt with in those companies' financial statements

There are no persons employed by the Company (2011 NII)
