#### **DIRECTORS' REPORT**

The directors present their Annual Report and the audited Financial Statements of NHL (3) Securities Limited ('the Company'), registration no 2637496, for the year ended 30 September 2011

#### **BUSINESS REVIEW AND PRINCIPAL ACTIVITIES**

The Company is a wholly owned subsidiary of The Paragon Group of Companies PLC ('the Group') The principal activity of the Company was the provision of mortgage loans secured by first charges over residential properties within the United Kingdom

The Company's profit and loss account is shown on page 5 The result after tax has fallen from a retained profit of £236,000 to a retained loss of £23,000.

The balance sheet on page 6 of the Financial Statements shows the Company's financial position at the year end Net assets have decreased due to the retained loss for the year Details of amounts owed from other group companies are shown in note 7

On 29 May 2012 the share capital of the Company was reduced to £12 in line with section 641 (1) (a) of the Companies Act 2006

The directors recommend no final dividend (2010 £nil) which, given the interim dividend of £nil per share (2010 4 55 pence per share), means a total dividend for the year of £nil per share (2010 4 55 pence per share)

The Group manages its operations on a centralised basis. For this reason, the Company's directors believe that further key performance indicators for the Company are not necessary or appropriate for an understanding of the development, performance or position of the business. The performance of the Group's mortgage lending operation, which includes the Company, is discussed in the Group's Annual Report, which does not form part of this Report.

#### PRINCIPAL RISKS AND UNCERTAINTIES

The Company's primary financial assets and liabilities are with other group companies, therefore the directors do not consider that the Company is exposed to any significant cash flow, credit or liquidity risks

After considering the above, the directors have a reasonable expectation that the Company will have adequate resources to continue in operational existence for the foreseeable future. For this reason, they continue to adopt the going concern basis in preparing the Financial Statements.

The Group recognises the importance of its environmental responsibilities, monitors its impact on the environment, and designs and implements policies to reduce any damage that might be caused by the Group's activities. The Company operates in accordance with group policies, which are described in the Group's Annual Report, which does not form part of this Report.

During the year ended 30 September 2010 the United Kingdom Government enacted provisions reducing the standard rate of corporation tax from 28% to 27% with effect from 1 April 2011. During the year ended 30 September 2011 it enacted further provisions reducing the rate to 26% with effect from 1 April 2011 and 25% from 1 April 2012. In the 2012 Budget, issued on 21 March 2012, the Chancellor announced that the main rate of corporation tax would be further reduced to 24% with effect from 1 April 2012, with further annual 1% rate reductions down to 22% by 1 April 2014. As these future rate reductions had not been enacted at the balance sheet date, they have not been reflected in these financial statements. The effect of these tax rate reductions will be accounted for in the period they are substantively enacted.

Therefore the standard rate of corporation tax applicable to the Company for the year ended 30 September 2011 is 27% and the rate is expected to be 25% in the year ending 30 September 2012
