

Its principle shareholders are certain trusts, none of which has a controlling interest in Virgin Travel Limited. The principal beneficiaries of those trusts are Sir Richard Branson and his immediate family.

Virgin Travel Limited changed its name to Virgin Group Investments Limited after 30 April 2000.

The largest group in which the results of the Company are consolidated is that headed by Ivanco (No.1) Limited, a company registered in England and Wales.
