Ceasing to hold office as auditors

Further to your correspondence and in accordance with Section 519 of the Companies Act 2006 (the Act), we confirm there are no circumstances connected with ceasing to hold office as auditors of Impellam Group plc (the "Company") and the subsidiaries listed in Appendix 1 that should be notified to those persons entitled to receive copies of the company's accounts.

The Act obliges PricewaterhouseCoopers LLP ("PwC") under Section 522(1) of the Act to notify the "appropriate audit authority" of the fact that PwC, as auditor of the Company, is leaving office and the reasons for our ceasing to hold office. As the audit of the Company meets the definition of a "major audit" under Section 525(2) of the Act and statutory guidance in relation to notifications by auditors and companies issued by the Financial Reporting Council ("FRC"), the appropriate audit authority is the FRC.

The FRC's statutory guidance contains a flowchart and relevant definitions to assist companies in relation to their reporting obligations.

If you have any concerns as to how the Company and its directors should meet their obligations in connection with the resignation and re-appointment of auditors then we recommend that you seek legal advice.
