IT IS ORDERED THAT:


- (1) the name of the above named Metallisation Industries Limited be restored to the Register of Companies

- (5) an Office Copy of the Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the Company is thereupon to be deemed to have continued in existence as if its name had not been struck off

official name in the "London Gazette"


