At an ANNUAL GENERAL MEETING of the above-named Company duly convened and held at St Columba's Church, Pont Street, London SW3 on 3rd May 2000 at 8.00 pm the following Resolutions were duly passed as SPECIAL RESOLUTIONS of the Company:—

SPECIAL RESOLUTIONS

(1) Alteration of Memorandum

THAT so that the business of the Company can be carried on more efficiently, the provisions of the Memorandum of Association of the Company be altered as follows:—

(a) In Clause 3, after "The company's objects are" insert:—

"(A) PRINCIPAL OBJECTS

The Principal Objects (described in this Memorandum and in the Articles of Association as "the Principal Activity") shall be:—"

- (b) Renumber Clause 1(i)-(iv) as (1)-(4)
- (c) Delete "(hereinafter constituting the Principal Activity)"
- (d) Insert:—
 - "(B) OTHER OBJECTS"
- (e) Renumber (2)-(17) as (1)-(16) and delete the proviso
- (f) Insert:—

"(17) To purchase and maintain insurance policies

To purchase and maintain for the purposes of the company or for the benefit of any person (including directors of the company) any insurance, including but not limited to any contract of insurance indemnifying any director or other officer against any liability which by virtue of any rule of law would otherwise attach to him in respect of any negligence, default, breach of duty or breach of trust of which he may be guilty in relation to the company

(18) To do other things incidental to the objects

To do all such other things as are incidental or conducive to the above objects or any of them"

(g) Insert:—



"4. OBJECTS TO BE SEPARATE AND DISTINCT

It is hereby declared that the objects of the company as specified in each of the foregoing paragraphs of clause 3 above shall be separate and distinct objects of the company and shall not be in any way limited by reference to any other paragraphs or the order in which the same occur

5. HEADINGS NOT PART OF MEMORANDUM

It is hereby declared that paragraph headings in this Memorandum and in the Table of Contents do not form part of this Memorandum"

(2) Alteration of Articles of Association

THAT the Articles of Association of the Company ("the existing Articles") be amended as follows:—

- (a) Articles 1.1 and 2 shall be deleted.
- (b) Article 3 of the existing Articles shall have added to it the definitions set out in Regulation 3 of Table A to form a new Article 1(1) replacing the existing Article 3.
- (c) The following paragraphs shall be added to the new Article 1(1):—
 - "(2) Expressions referring to writing shall, unless the contrary intention appears, be construed as including references to printing, lithography, photography, and other modes of representing or reproducing words in a visible form
 - (3) Unless the context otherwise requires, words or expressions contained in these articles shall bear the same meaning as in the Act or any statutory modification thereof in force at the date at which these articles become binding on the company and "person" includes a company or other body corporate
 - (4) Paragraph headings used in these articles and in the Table of Contents and the Table of Contents itself do not form part of the articles of association of the company"
- (d) Article 1.2 shall be renumbered as Article 2.
- (e) The text of those regulations of Table A which are mentioned in the Schedule to this resolution shall be inserted verbatim into the existing Articles in the places and subject to the variations shown in that Schedule, the origin of each of the new Articles being shown also in the second or third column of the Schedule.
- (f) Save for the Articles mentioned in the Schedule, all existing Articles, including all incorporations of Table A, are deleted.
- (g) For all references in the existing Articles to the Retail Price Index there shall be substituted a reference to the General Index of Retail Prices (All Items), for all references to £1,000 there shall be substituted a reference to £1,500 and for all references to £25,000 there shall be substituted a reference to £30,000.
- (h) The existing Articles and cross-references in the existing Articles to other Articles shall be renumbered in accordance with the left hand column in the Schedule and the following additional Articles or paragraphs of Articles inserted where shown:—
 - "6. The company shall not recognise any trust but nothing in this prohibition shall prevent the trustees of any trust from registering themselves as members if they shall otherwise be properly qualified for membership, in which case they shall be treated for the purposes of voting as single or joint members according to the number of trustees in question
 - 42(4) Any person who is related by blood adoption or marriage to, or any person nominated for that purpose by a company which is, a duly qualified member shall be eligible to become a director
 - 43(2) Article 47(3) shall apply for the indexation of the sum of £1,500 mentioned in paragraph (1) of this article as it does for the sum of £30,000 mentioned in article 47
 - 48(2) Article 47(3) shall apply for the indexation of the sum of £30,000 mentioned in paragraph (1) of this article as it does for the sum of £30,000 mentioned in article 47

- 58(2) Any director or member of a committee of directors may participate in a meeting of the directors or such committee by means of a conference telephone or similar communications equipment whereby all persons meeting in this manner shall be deemed to constitute presence at such meeting
- 64(e) the resolution relates in any way to the purchase and/or maintenance of any insurance policy under which he may benefit"
